**NOTICE (Revised Programme for PG Dental Courses)**

The counselling programme for admission to PG Dental Courses in Govt./ Private Medical Colleges of Bihar was published at para-5 in the Adv. No. BCECEB(PGMAC)-2018/04 dated 11.04.2018. In the above counselling programme for admission to PG Dental Degree / Deiploma courses in Govt./ Private colleges, the PGMAC ID of those candidates who obtained minimum 50<sup>th</sup> Percentile for Unreserved (General), 40<sup>th</sup> Percentile for SC/ST/OBC (BC & EBC) and 45<sup>th</sup> Percentile for DQ in NEET-MDS 2018 were included for 1<sup>st</sup> Counselling. The same is revised and candidates who obtained minimum 20.265<sup>th</sup> Percentile for Unreserved (General), 10.265<sup>th</sup> Percentile for SC/ST/OBC (BC & EBC) and 15.265<sup>th</sup> Percentile for DQ marks in NEET-MDS 2018 (Vide letter no. सं.सं.-1/विधि-74/2016-438(1) स्वा०, पटना, दिनांक 13.04.2018 & Ref. No. NBE/III/NEET-MDS/2018/22728 DT. 23.03.2018) are included in the revised 1<sup>st</sup> Counselling programme PGMAC ID merit wise for PG Dental courses in Govt. / Private Dental Colleges is given in para 2.1 below.

3. **The candidates are required to bring all the certificates / documents alongwith the Hard Copy of Part-A & Part-B of the Online Submitted Application as per the prospectus of PGMAC-2018 and also bring original Aadhar card and its Photocopy positively at the time of counselling.**

4. Inclusion of any PGMAC - ID in the above Counselling/ Interview programme does not guarantee admission. Candidates in excess of the available seats are being called for Counselling / Interview in order to ensure filling up vacancies which may arise due to absentees.

8. If a candidate called for Counselling / Interview is found ineligible as per the requirements of the prospectus of PGMAC-2018 and / or the latest order/ orders passed by the Hon'ble High Court/ Supreme Court or Department of Health in matters related to PGMAC-2018, his / her candidature is liable to be rejected.

6. Each eligible candidate will be allowed to exercise his/ her option for Course/ Institution from amongst those available at his/ her merit serial after his/ her original Certificates/ Documents and identity are verified.

7. A candidate who absents or fails to appear on the scheduled date & time of his/ her Counselling/ Interview may appear for Counselling any time during the period of Counselling of his/ her respective category, but in that case he/ she will have the option of Course/ Institution available at the time of his/ her actual reporting.

8. Each candidate should note that once the Course/ Institution is opted at the time of his/ her Counselling at his merit serial and the same is allotted to him/ her, no subsequent request for change of course and/ or Institution shall be entertained.

9. Admission fee and other related charges shall have to be deposited at the time of admission in the concerned college.

10. In case of dispute, decision of the Controller of Examination, BCECEB shall be final.

11. The Govt. of Bihar and the Bihar Combined Entrance Competitive Examination Board reserve the right to amend the rules relating to PGMAC-2018.

12. Any typographical error inspite of all precautions taken and detected any time shall be corrected whenever detected and merely publication of PGMAC - ID will not confer any right for admission.
