In continuation to Advertisement No. BCECEB(PGMAC)-2018/11 dt. 08.05.2018, it is to inform to all concerned that the list of all qualified candidates of NEET-PG 2018 and NEET-MDS 2018, received by National Board of Examination (NBE)/ Health Department, Govt. of Bihar, for admission to First year of the Post Graduate Degree / Diploma courses in Government / Private Medical & Dental colleges of Bihar after 2nd Counselling conducted from 10.05.2018 to 13.05.2018 for MOP UP Counselling will be uploaded on Board's website bceceboard.bihar.gov.in.

**2. MOP UP Counselling for all vacant seats in Government / Private Medical & Dental Colleges of Bihar will be held on 15.05.2018. Counselling programme and other details will be uploaded on Board's website vide BCECEB(PGMAC)-2018/13 dt. 12.05.2018.**

**3. All concerned candidates will report at BCECE Board's office at 9.00 A.M. on 15.05.2018.**

**4. The candidates who are admitted in any institution either under AIQ or State Quota are not eligible for MOP UP Counselling.**

**5. All terms and condition will remain same as in Advertisement No. BCECEB(PGMAC)-2018/01 & 2018/02 Dated : 31.03.2018 and BCECEB(PGMAC)-2018/11 Dated : 08.05.2018.**

**6. Reservation policy for counselling of the vacant seats (after admission on the basis of common second counsellings) for state Govt colleges will be the same as was followed in common second counselling vide Health Department's Circular No. 1/प.नि.-04/2017.743(1)/ स्वा., पटना, दिनांक 11.07.2017.**

**7. As per letter no.-1/विधि-74/2016-501(1) dated 10.05.2018 of Deptt. of Health, Govt. of Bihar and order of Hon'ble Supreme court passed in WP(Civil) No. 244/2017 Educational promotion society of India and ors. dt. 04.05.2017, the seats reserved for minorities, if any, will be filled up by minority students in order of merit, as a result of which, rights of minority institutions are fully protected. In the event of any seat in a minority institution is not filled up by a minority student, then the said seat shall be filled up by the General category student in order of merit, in the MOP UP counselling to be held on 15.05.2018.**

**8. The candidates are directed to come for MOP UP counselling with all required original documents as per prospectus of PGMAC-2018 and also as mentioned in Advertisement No. BCECEB(PGMAC)-2018/01 & 2018/02 Dated 31.3.2018 so that his/her admission may be taken same day i.e. 15.05.2018 otherwise they will not be allotted seat in this MOP UP Counselling..**
