The counselling programme for admissions to the first year of MD (Homoeo) courses based on the merit of All India Ayush Post Graduate Entrance Test (AIAPGET)-2018 will be held on 25.10.2018 at I.A.S. Bhawan, Near Patna Airport, Patna-800014 as announced vide Adv. No.- BCECEB(PGMAC)-2018/15 Dated 15.10.2018 & 2018/17 Dated 15.10.2018.

2. The candidates who are qualified on the basis of AIAPGET-2018 and who have duly applied in response to Adv. No.- BCECEB(PGMAC)-2018/15 Dated 15.10.2018 & 2018/17 Dated 15.10.2018 are included in the counselling programme for allotment of MD (Homoeo) courses in R.B.T.S. Govt. Homoeopathy Medical College & Hospital, Muzaffarpur as per corresponding eligibility criteria.

3. Each candidate eligible as per para 2 above has to appear for counselling on the scheduled date alongwith already 'online' filled part-A and Part-B of application form, the original certificates / documents and other required enclosures as per the prospectus of PGMAC-2018 for MD (Homoeo). After verification of certificates / documents/ identity, the course / institution will be allotted merit wise to eligible candidates as per prospectus of PGMAC-2018 for MD (Homoeo).

4. The PGMAC (Homoeo) ID of reserve category candidates who competed in Unreserved (General) category have been included in Unreserved (General) category as well as their respective reserve categories. **Therefore, reserve category candidates who are included in Unreserved (General) Category must come for counselling on the date fixed for the same at their Unreserved (General) Category merit serial for option of course / institution available in Unreserved (General) category and then must come for counselling on the date fixed for allotment of Course / Institution available at their Reserve category merit serial.**

6. **The candidates are required to bring all the certificates/documents as as per the prospectus of PGMAC-2017 for MD (Homoeo) positively at the time of counselling otherwise they will not be eligible for admission.**

7. Inclusion of any PGMAC (Homoeo) ID in the above Counselling/ Interview programme does not guarantee admission. Candidates in excess of the available seats are being called for Counselling / Interview in order to ensure filling up vacancies which may arise due to absentees.

8. If a candidate called for Counselling / Interview is found ineligible as per the requirements of the prospectus of PGMAC-2018 for MD (Homoeo) and / or the latest order/ orders passed by the Hon'ble High Court/ Supreme Court or Department of Health in matters related to PGMAC-2018 for MD (Homoeo) , his / her candidature is liable to be rejected.

9. Each eligible candidate will be allowed to exercise his/ her option for Course/ Institution from amongst those available at his/ her merit serial after his/ her original Certificates/ Documents and identity are verified.

10. A candidate who absents or fails to appear on the scheduled date & time of his/ her Counselling/Interview may appear for Counselling any time during the period of Counselling of his/her respective category, but in that case he/ she will have the option of Course/ Institution available at the time of his/ her actual reporting.

11. Each candidate should note that once the Course/ Institution is opted at the time of his/ her Counselling at his merit serial and the same is allotted to him/ her, no subsequent request for change of course and/ or Institution shall be entertained.

12. Admission fee and other related charges shall have to be deposited at the time of admission in the concerned college.

13. In case of dispute, decision of the Controller of Examination, BCECEB shall be final.

14. The Govt. of Bihar and the Bihar Combined Entrance Competitive Examination Board reserve the right to amend the rules relating to PGMAC-2018 for MD (Homoeo).

15. Any typographical error inspite of all precautions taken and detected any time shall be corrected whenever detected and merely publication of PGMAC (Homoeo) ID will not confer any right for admission.
