**NOTICE**

In continuation to Adv. no.- BCECEB(PGMAC)-2018/18 Dated : 23.10.2018, the second counselling programme for admissions to the first year of MD (Ayurveda) courses based on the merit of All India Ayush Post Graduate Entrance Test (AIAPGET)-2018 will be held on 15.11.2018 at I.A.S. Bhawan, Near Patna Airport, Patna-800014.

2. In accordance with the letter no.-16/ एच. 1-12/2017-1404 (आ.चि.) दिनांक 05.11.2018 of the Deptt. of Health, Govt. of Bihar and the letter no.-F.No.-R-11011/02/2018-EP(1M-1) Part1 dated 26.10.2018 of the Ministry of Ayush, Govt. of India, the minimum eligibility marks of the entrance test for in admission in the case of General Candidate shall be fiftieth (50th) percentile, in the case of candidates belonging to the schedule caste, the schedule tribes and regular central or state service candidates shall be fortieth (40th) percentile and in the case of candidates belonging to the Other Backward Classes shall be forty fifth (45th) percentile in the AIAPGET-2018.

(i) Accordingly the online application on prescribed form are invited from all over India from AIAPGET-2018 qualified and interested candidates from 09.11.2018 to 11.11.2018 on the basis of revised eligibility criteria as mention in para-2 above.

(ii) The candidates who have already applied in response to Adv no.-BCECEB(PGMAC)-2018/15 dated 15.10.2018 need not apply again.

3. The procedure for online submission of Application Form,

Procurement of prospectus and counselling fee, the details are mentioned in Adv. no.-BCECEB(PGMAC)-2018/15 dated 15.10.2018 available on Board's website.

4. The second counselling programme, for PGMAC(Ayurveda) will be uploaded on Board's website on 12.11.2018 and the second counselling will be conducted on 15.11.2018.

5. **The candidates are required to bring all the certificates/documents as as per the prospectus of PGMAC-2018 for MD (Ayurveda) positively at the time of counselling otherwise they will not be eligible for admission.**

6. Inclusion of any PGMAC (Ayurveda) ID in the above Counselling/ Interview programme does not guarantee admission. Candidates in excess of the available seats are being called for Counselling / Interview in order to ensure filling up vacancies which may arise due to absentees.

7. If a candidate called for Counselling / Interview is found ineligible as per the requirements of the prospectus of PGMAC-2018 for MD (Ayurveda) and / or the latest order/ orders passed by the Hon'ble High Court/ Supreme Court or Department of Health in matters related to PGMAC-2018 for MD (Ayurveda), his / her candidature is liable to be rejected.

8. Each eligible candidate will be allowed to exercise his/ her option for Course/ Institution from amongst those available at his/ her merit serial after his/ her original Certificates/ Documents and identity are verified.

9. A candidate who absents or fails to appear on the scheduled date & time of his/ her Counselling/Interview may appear for Counselling any time during the period of Counselling of his/her respective category, but in that case he/ she will have the option of Course/ Institution available at the time of his/ her actual reporting.

10. Each candidate should note that once the Course/ Institution is opted at the time of his/ her Counselling at his merit serial and the same is allotted to him/ her, no subsequent request for change of course and/ or Institution shall be entertained.

11. Admission fee and other related charges shall have to be deposited at the time of admission in the concerned college.

12. In case of dispute, decision of the Controller of Examination, BCECEB shall be final.

13. The Govt. of Bihar and the Bihar Combined Entrance Competitive Examination Board reserve the right to amend the rules relating to PGMAC-2018 for MD (Ayurveda).

14. Any typographical error inspite of all precautions taken and detected any time shall be corrected whenever detected and merely publication of PGMAC (Ayurveda) ID will not confer any right for admission.
