NOTICE for 2nd Counselling Programme

The Second counselling programme for admissions to the first year of MD (Ayurveda) courses based on the merit of All India Ayush Post Graduate Entrance Test (AIAPGET)-2018 will be held on 15.11.2018 at I.A.S. Bhawan, Near Patna Airport, Patna-800014 as announced vide Adv. No.- BCECEB(PGMAC)-2018/20 Dated 08.11.2018.

2. The candidates who have duly applied in response to Adv. No.- BCECEB(PGMAC)-2018/15 dt. 15.10.2018 are also eligible for appearing in second counselling for admission against vacant seats in MD (Ayurveda) course in Ayurvedic College of Bihar after admission on the basis of 1st Counselling as per Adv. No.- BCECEB(PGMAC)-2018/18 dt. 22.10.2018 available seats.

2.1 The candidates who have duly applied in response to Adv. No.- BCECEB(PGMAC)-2018/20 dt. 08.11.2018 are eligible for appearing in second counselling for admission against vacant seats in MD (Ayurveda) courses in Govt. Ayurvedic College of Bihar after admission on the basis of 1st Counselling.

3. Each candidate eligible as per para 2 & 2.1 above has to appear for counselling on the scheduled date alongwith hard copy (Part-A & Part-B) of the online filled application form, the original certificates / documents and other required enclosures as per the prospectus of PGMAC-2018. After verification of certificates / documents/ identity the course / institution will be allotted merit / rank wise to eligible candidates as per prospectus of PGMAC-2018 (Ayurveda) .

4. The PGMAC (Ayurveda) ID of reserve category candidates who competed in Unreserved (General) category have been included in Unreserved (General) category as well as their respective reserve categories. **Therefore, reserve category candidates who are included in Unreserved (General) Category must come for counselling on the date fixed for the same at their Unreserved (General) Category merit serial for option of course / institution available in Unreserved (General) category and then must come for counselling on the date fixed for allotment of Course / Institution available at their Reserve category merit serial.**

6. PGMAC ID of those candidates whose PGMAC ID was included in merit list for 1st Counselling is also included in the above merit list. The candidates who have taken admission on the basis of 1st counselling and want to reshuffle their course as per vacancy on the basis of merit-cum-choice may appear in 2nd counselling at their merit serial with bonafide certificate and other required documents.

7. **The candidates are required to bring all the certificates/documents as as per the prospectus of PGMAC-2018 for MD (Ayurveda) positively at the time of counselling otherwise they will not be eligible for admission.**

8. Inclusion of any PGMAC (Ayurveda) ID in the above Counselling/ Interview programme does not guarantee admission. Candidates in excess of the available seats are being called for Counselling / Interview in order to ensure filling up vacancies which may arise due to absentees.

9. If a candidate called for Counselling / Interview is found ineligible as per the requirements of the prospectus of PGMAC-2018 for MD (Ayurveda) and / or the latest order/ orders passed by the Hon'ble High Court/ Supreme Court or Department of Health in matters related to PGMAC-2018 for MD (Ayurveda) , his / her candidature is liable to be rejected.

10. Each eligible candidate will be allowed to exercise his/ her option for Course/ Institution from amongst those available at his/ her merit serial after his/ her original Certificates/ Documents and identity are verified.

11. A candidate who absents or fails to appear on the scheduled date & time of his/ her Counselling/Interview may appear for Counselling any time during the period of Counselling of his/her respective category, but in that case he/ she will have the option of Course/ Institution available at the time of his/ her actual reporting.

12. Each candidate should note that once the Course/ Institution is opted at the time of his/ her Counselling at his merit serial and the same is allotted to him/ her, no subsequent request for change of course and/ or Institution shall be entertained.
16. Admission fee and other related charges shall have to be deposited at the time of admission in the concerned college.
14. In case of dispute, decision of the Controller of Examination, BCECEB shall be final.
15. The Govt. of Bihar and the Bihar Combined Entrance Competitive Examination Board reserve the right to amend the rules relating to PGMAC-2018 for MD (Ayurveda).
16. Any typographical error inspite of all precautions taken and detected any time shall be corrected whenever detected and merely publication of PGMAC (Ayurveda) ID will not confer any right for admission.
