## Important Notice for 2nd MOP-UP Counselling (for Dental Colleges of Bihar)

- 1. Fressh Registration and application form were obtained from the NEET(UG)-2019 eligible candidates vide Advertisement No.BCECEB(UGMAC)-2019/28, 2019/29 Dated 03.09.2019 & BCECEB(UGMAC)-2019/30 Dated 07.09.2019 in the light of revision of qualifying percentile by D.C.I. for admission in to BDS Course,.
- 2. UGMAC ID of all candidates, who have duly submitted the online application form for UGMAC-2019 in the light of Adv. No. BCECEB(UGMAC)-2019/28, 2019/29 dt. 03.09.2019 & BCECEB(UGMAC)-2019/30 dt. 07.09.2019 and found eligible as per the revised NEET Cut-off Marks are included Merit-row wise in the 2nd MOP-UP counselling programme.
- 3. Those NEET(UG)-2019 qualified candidates who are included in merit list and all concerned institutions are here by informed that on the vacant seats after admission on the basis of UGMAC-2019 MOP-UP Counselling, 2nd OFFLINE MOP-UP Counselling will be held on 12.09.2019.
- 4. 2nd MOP-UP Counselling will be held in the premises of BCECE Board office, IAS Bhawan, Patna-14.
- 5. For admission in Dental colleges of Bihar state, only such NEET(UG)-2019 candidates are eligible who fulfill the eligibility criteria as per the prospectus and are not admitted in any Govt./ Pvt. Medical/Dental Colleges of India. The detailed 2nd MOP-UP counselling programme / process have been uploaded on the Board's website: bceceboard.bihar.gov.in vide adv. No. BCECEB(UGMAC)-2019/32 Dated 10.09.2019.
- 6(a). All candidates who want to participate and to take the admission on the vacant seats available after admission on the basis of MOP-UP round counselling at their merit in Dental Colleges have to take admission on the same day during 2nd MOP-UP counselling process by submitting the required original documents and requisite fee amount.
- (b). All candidates who want to take admission in Pvt. Dental Colleges are required to submit a Demand Draft of Rs.50,000/- (fifty thousand) in favour of Controller of Examination, BCECE Board payable at Patna failing which they would not be given chance for Document Verification and admission. If the candidate is admitted, he has to deposit cheque of rest amount of fee of that institution. After admission the candidate will submit bank draft of the cheque amount to the institution and institution will return his deposited cheque.
