**NOTICE for Mop-up Counselling**

Fresh Registration and Submission of Online Application form are invited from All India Ayush Post Graduate Entrance Test (AIAPGET)-2021 interested qualified and eligible candidates for appearing in the Post Graduate Medical Admission Counselling (PGMAC)-2021 for MD (Ayurveda) Mop-up Counselling in order to select candidates for admission to the FIRST YEAR of the following Post Graduate Degree Courses on the vacant seats after 1st counselling held on 21.04.2022 as per Adv. No.- BCECEB[PGMAC(Ayush)]-2021/09 Dated 18.04.2022 in following Govt./ Pvt. Ayurvedic colleges;

- a. Govt. Ayurvedic College, Patna for the session 2021.
  - b. D.A.Medical College & Hospital, Siwan (Private) for the session 2021.
2. Those candidates who are admitted in any Institution of India upto completion of Counselling conducted by AACCC or State Counselling are not eligible for this counselling. So, such candidates are advised not to apply for this counselling.
  3. Those candidates who have successfully / duly filled their online application form earlier in the light of Adv. No. BCECEB(PGMAC)-2021/03 & 2021/04 dated 09.04.2022 and want to participate in this counselling have also to fill the fresh application form.
  - 4.(a) Category wise Seat Matrix of Vacant Seats after completion of 1st round counselling is already uploaded on the Board's Website.
  - (b) Actual updated vacancy position will be uploaded on Board's website before start of counselling.
  5. **Eligibility criteria and instructions and other details are available in the prospectus of PGMAC-2021 for MD (Ayurveda) which can be downloaded from the Board's website [bceceboard.bihar.gov.in](http://bceceboard.bihar.gov.in).**
  6. **Procedure for Online Submission of Application Form, procurement of Prospectus and Counselling Fee :** The Prospectus for appearing in PGMAC (Ayush) for MD (Ayurveda)-2021 can be downloaded Online from the BCECE Board's website : [bceceboard.bihar.gov.in](http://bceceboard.bihar.gov.in) by clicking on the link "**PGMAC (Ayush) -2021 [MD (AYURVEDA)]**" under Prospectus Section. After that click on "**Online Application portal of PGMAC [MD (Ayurveda)]-2021**" and follow the instructions appearing on the computer screen.
- I. **Step-One - Registration :** For registering, the candidate is required to fill the information asked in Step-One of the application form, appearing on the computer screen. Candidate must enter their AIAPGET-2021 Roll No. and then click on verify button then Candidate while registering, all informations concerning registration will be sent on the email ID and Mobile No. given in online application form. Also the candidate will receive a SMS. The received email and SMS will contain an "**ACTIVATION CODE**" which is to be used by the candidate to activate his account. The candidate should click "**Activate Your Account**" Button and enter the email ID and received Activation code to activate his / her account. There after click the "**Submit**" button. After activating the account the candidate should click the "**Sign In**" button and enter the email Id and password to proceed further. The candidate must keep the password entered in Application Form confidential, otherwise BCECE Board will not be responsible for any complication. The email id given by the candidate will be his user name.
  - II. **Step-two - (Personal Information) :** After successful registration and activating the account, the candidate should again "**Sign in**" to his account and thereafter complete the required entries regarding personal information on the computer screen. Then click on "**Save & Continue**" button.
  - III. **Step-Three - (Upload Photo and Signature) :** After entering the personal information the candidate should upload his / her passport size photograph as uploaded in AIAPGET-2021 online application form and full signature in Hindi and English (Not in capital letter) after duly scanning the same. After uploading photo and signature click on "**Save & Continue**" button.
  - IV. **Step-Four - (Educational Information) :** After uploading the scanned photo and signature the candidate should enter his / her educational information on the computer screen and click on "**Save & Continue**" button.
  - V. **Step - Five (Preview your application) :** After entering educational information the candidate must verify all the information given by him/her while verifying given information in step-2, step-3 and step-4. If any information is found wrong, then the candidate should click "**Back to Edit**" button and make required corrections. Thereafter the candidate should click "**Save & Continue**" button so that entered information should be updated.  
If preview of application form is found to be correct, then the candidate give his / her Declaration and click the "**Confirm & Submit**" button so that he / she should pay Examination Fee as per Step-Six.
  - VI. **Step - Six (Payment of Counselling Fee) :** After preview of the Application Form and submitting the same, the candidate should click "**Proceed to Payment**" button and complete the payment procedure according to instructions appeared on the computer screen regarding payment of Counselling Fee. Paid Counselling Fee will not to be refunded. There are following modes for payment of Counselling Fee.
    - a. **Online Payment :** Candidate have to pay Counselling Fee through Online mode e.g. Credit Card / Debit Card / Net

banking, he / she should select online option from payment mode appearing on the computer screen and "**Make the Payment**" should be made through Credit Card / Debit Card / Net banking. The candidate has to pay processing charge additional to Counselling Fee for payment through online mode

- b. Counselling Fee :** Counselling fee to be paid through above modes is Rs. 2200/- (Two Thousand Two Hundred) only for all categories i.e. (Unreserved / SC / ST / EBC / BC / DQ) candidates.

**VII. Step - Seven (Download part- A & Part-B) :** After payment of Counselling Fee upto scheduled date and time, the candidate must download Hard Copy (Part-A & and Part-B) of online submitted Application Form and keep the same safely in his possession because it contains all informations provided by the candidate and the PGMAC (Ayush) -ID made available by the Board for further use during counselling.

**Note :** a. Hard copy of PART-A & PART-B need not to be send Board's office, but instead this is to be made available at the time of counselling.

- b. After completing the above procedure and finally submitting the online application form, there is no provision for any change or modification in the same.
- c. The candidate must note that after submission of online application form, neither it can be withdrawn nor any request for refunding paid counselling fee will be entertained.
- d. Board will not be responsible for any interruption in Internet / Postal / Banking system. Therefore the candidates must not wait for last dates and complete all procedure before due date.
- e. Final Merit list for Ayurveda course will be prepared after scrutinising the data provided by National Testing Agency / Health Deptt., Govt. of Bihar.
- f. No other chance will be given to any candidate for submitting online application after due date for online submission of application.
- g. Incomplete Application form will not be entertained and will be summarily rejected.
- h. Counselling programme / Rank card will be published on Board's website on 07.05.2022 (8.00 P.M.)
7. (i) After online submission of application, if the applicant finds that while filling up such application the error regarding any entries/ photo / signature uplodng has / have been made, then he/ she will have opportunity to edit / rectify the same on 06.05.2022.
- (ii) The above mentioned editing / rectification / correction opportunity will be available for only those candidates, who have successfully filled their online application form and make the payment successfully within due date.
- (iii) For making rectification / correction / editing in online submitted application, the candidate is required to enter the email ID & Password and click on "**Sign In**" button for getting his account to login whereby the editing process can be carried out.

10. Candidate will have to produce his/her all original certificate during the time of document verification / seat allotment process for Mop-Up counselling, otherwise he / she will not be considered for Mop-up Counselling. In case of opting seat for admission their original documents will be retained.
11. **The candidates desirous of opting seats in any Private Ayurvedic Colleges, has to deposit a bank draft of Rs. 50000/- (Fifty thousand) only in the favour of Controller of Examination, BCECE Board payable at Patna at the time of Counselling. If the candidate doesn't take admission on his allotted seat, the deposited amount will be forfeited and in case of taking admission, he/she has to deposit the rest amount of required fee to the concerned institution.**
