**NOTICE**

The counselling for admissions to the first year of MD /MS (Ayurveda) courses based on the merit of All India Ayush Post Graduate Entrance Test (AIAPGET)-2022 will be held on 25.02.2023 at I.A.S. Bhawan, Near Patna Airport, Patna-800014 as announced vide Adv. No.- BCECEB(PGMAC)-2022/03 & 2022/04 Dated 09.02.2023.

2. The candidates who are qualified on the basis of AIAPGET-2022 and who have duly applied in response to Adv. No.- BCECEB(PGMAC)-2022/03 & 2022/04 Dated 11.02.2023 and found eligible are included in the counselling programme for allotment of MD /MS (Ayurveda) courses in Govt. Ayurvedic College, Patna / D.A.Medical College & Hospital, Siwan (Private) as per corresponding eligibility criteria.

3. Each candidate eligible as per para 2 has to appear for counselling on the scheduled date alongwith already 'online' filled part-A and Part-B of application form, the original certificates / documents and other required enclosures as per the prospectus of PGMAC-2022 [Ayush] for MD /MS (Ayurveda). After verification of certificates / documents/ identity, the course / institution will be allotted on the basis of Merit-cum-choice to eligible candidates as per prospectus of PGMAC-2022 [Ayush] for MD /MS (Ayurveda).

5. The PGMAC - ID of reserve category candidates who competed in Unreserved category have been included in Unreserved (UR) as well as in their respective reserved categories. The seat of reserved category will remain open during the counselling of UR category and MRC candidates present in UR merit list will have option to opt UR seat as well as there category seat. **Therefore, Meritorius Reserve Category (MRC) candidates who are included in Unreserved Category must come for counselling on the date fixed at their Unreserved Category merit serial for option of course / institution available in Unreserved category as well as reserve category,** otherwise the reserved category seat available at their merit Serial may be opted and allotted to the candidate of lower merit for which be they themself could be responsible.

6. Counselling for all vacant seats in Govt./ Private Ayurvedic Medical Colleges of Bihar will be held off-line on 25.02.2023.
7. The candidates participating in the Counselling on scheduled date & time are advised to come prepared for staying next day, if needed.
8. The Seat matrix for counselling is available on Board's website: bceceboard.bihar.gov.in. The candidates are advised to see the vacancy before attending the counselling.
9. Inclusion of any PGMAC - ID in the above Counselling/ Interview programme does not guarantee admission. Candidates in excess of the available seats are being called for Counselling / Interview in order to ensure filling up vacancies which may arise due to absentees. Hence, if seats field up, counselling of concerned category will be postponed and then rest of the candidates have to return back.
10. **The candidates who are admitted in any Govt. / Pvt. institution under All India Quota in India conducted by AACCC are not eligible for Counselling.**
11. **The candidates are required to bring all the certificates/documents as as per the prospectus of PGMAC-2022 [Ayush] for MD /MS (Ayurveda) positively at the time of counselling otherwise they will not be eligible for admission.**
12. **Rank Card of PGMAC (Ayush)-2022 is available on Board's website. Candidates can download their rank card by visiting the link "Rank Card of PGMAC (Ayush)-2022 [Homeo / Ayurveda / Unani]" and by entering their own PGMAC ID and Date of Birth.**
13. If a candidate called for Counselling / Interview is found ineligible as per the requirements of the prospectus of PGMAC-2022 for MD / MS (Ayurveda) and / or the latest order/ orders passed by the Hon'ble High Court/ Supreme Court or Department of Health in matters related to PGMAC-2022 for MD /MS (Ayurveda), his / her candidature is liable to be rejected.
14. Each eligible candidate will be allowed to exercise his/ her option for Course/ Institution from amongst those available at his/ her merit serial after his/ her original Certificates/ Documents and identity are verified.
15. A candidate who absents or fails to appear on the scheduled date & time of his/ her Counselling/Interview may appear for Counselling any time during the period of Counselling of his/her respective category, but in that case he/ she will have the option of Course/ Institution available at the time of his/ her actual reporting.
16. All the certificates included in the list given below, if applicable, must be submitted in original by every candidate at the time of his / her counselling / allotment on the scheduled date ;
  - (i) Original Admit Card and Rank Card of AIAPGET-2022
  - (ii) Passing Certificate / Mark sheet / Admit Card of Matric / equivalent exam.
  - (iii) Passing Certificate / Mark sheet / Admit Card of Intermediate/ 10+2 / equivalent exam.
  - (iv) Passing Certificate / Mark sheet / Admit Card of BAMS Degree.
  - (v) Residential Certificate.
  - (vi) Caste Certificate.
  - (vii) Rotatory internship completion certificate.
  - (viii) No objection certificate from employer, if any.
  - (ix) Ayurveda Registration certificate.
  - (x) Six copies of the passport size photographs, which was pasted on the Admit Card of AIAPGET-2022.
  - (xi) Downloaded print of Online filled Application Form (Part A & Part B) of PGMAC for MD /MS (AYURVEDA)-2022.
  - (xii) Aadhar Card.
  - xiii. Rank Card of PGMAC(Ayush)-2022 [Ayurveda].
  - xiv. The Check Slip (जाँच-पत्ती) as downloaded alongwith Rank Card in 2 (Two) copies, Biometric Identification Report Form 1 (one) copy.
  - (xv) Any other documents required (if any) such as DQ (PH) / EWS certificate.
17. Each candidate should note that once the Course/ Institution is opted at the time of his/ her Counselling at his merit serial and the same is allotted to him/ her, no subsequent request for change of course and/ or Institution shall be entertained.
18. Admission fee and other related charges shall have to be deposited at the time of admission in the concerned college.
19. Fees structure for Private Ayurvedic College wise is already available on Board's website.
20. In case of dispute, decision of the Controller of Examination, BCECEB shall be final.
21. The Govt. of Bihar and Bihar Combined Entrance Competitive Examination Board reserves the right to amend the rules relating to PGMAC-2022 for MD /MS (Ayurveda).
22. Any typographical error inspite of all precautions taken and detected any time shall be corrected whenever detected and merely publication of PGMAC ID will not confer any right for admission.
