NOTICE for 2nd Counselling

Pursuant to the public Notice of National Commission for Indian System of Medicine, Ministry of Ayush, Govt. of India, New Delhi letter No.-AIAPGET/COE/2023 dated 09.11.2023 regarding lowering down the qualifying cut-off percentile for PG(Ayush) Courses. **Fresh Registration and Submission of Online Application form** are invited from interested qualified candidates on the basis of All India Ayush Post Graduate Entrance Test (AIAPGET)-2023 [Ayurveda] for appearing in the Post Graduate Medical Admission Counselling [PGMAC (Ayush)]-2023 for MD / MS (Ayurveda) [2nd counselling] in order to select candidates for admission on the vacant seats after admission on the basis of PGMAC (Ayush)-2023 for MD (Ayurveda) 1st round offline counselling held on 09.11.2023.

2. Those candidates who have already duly submitted the Online Application Form and paid the counselling fee against Adv. No.-BCECEB [PGMAC(Ayush)]-2023/03 Dated : 26.10.2023 for MD (Ayurveda) need not to apply / submit Online Application Form again. The candidates who either have not been allotted or admitted on the basis of 1st offline counselling of PGMAC (Ayush)-2023 held on 09.11.2023 will be eligible for either fresh allotment or reshuffle. In case of reshuffle, Admitted candidates has to bring Admission Receipt and bonafide certificate from the Principal of concerned Institute that he is a bonafide student of the Institute and following document (List of Documents) is deposited in the Institution.

3. Eligibility criteria for counselling, Fee payment procedure, instructions and other details are available in the prospectus of PGMAC (Ayush) -2023 for MD / MS (Ayurveda) and the related Advertisement No.- BCECEB [PGMAC(Ayush)]-2023/10 Dated 17.11.2023 respectively, can be downloaded from the Board's website bceceboard.bihar.gov.in. Online Registration will start from 19.11.2023 and close on 24.11.2023 (10.00 P.M.).

4. The candidates eligible as per guidelines of AACCC & CCIM and applied for 2nd Counselling must reach Board's Office for counselling as per above schedule i.e. on 29.11.2023. Due to paucity of times. Candidate are being informed that they are required to be prepared to reach the Counselling venue BCECE Board office, IAS Bhagawan, Near Patna Airport, Patna.
