Notice for Round-3 Online Counselling

Fresh Online Registration and submission of Application form are invited from such qualified, eligible & interested AIAPGET-2024 candidates for appearing in the 3rd Round Online Counselling of Post Graduate Medical Admission Counselling [PGMAC (Ayush)]-2024 for MD / MS (Ayurveda) / MD (Homoeo) / MD (Unani) Courses, who are not admitted in any Ayush Colleges of India, on the vacant seats of Government/ Private Ayush Colleges of Bihar after admission on the basis of PGMAC (Ayush)-2024 Online 2nd round counselling held from 23.10.2024 to 24.10.2024.

- 2. Round-3 Counselling will be conducted Online.
- 3. Such candidates who have joined / taken admission on the basis of AIQ (up to Round-2 Counselling) are not eligible for PGMAC (Ayush)-2024 Round-3 Counselling. Hence they need not to submit fresh Online Application Form.
- 4. In the light of Adv.No.BCECEB[PGMAC (Ayush)]-2024/07, 2024/08, 2024/09 dated: 27.09.2024 & 2024/12 dated: 09.10.2024 and 2024/14 dated: 18.10.2024, candidates who have been allotted a seat and has taken admission by verifying their documents on their respective Seat / Institution on the basis of Round-1 / Round-2 Counselling and have not resigned from their Round-1 / Round-2 Allotted seat are not eligible for PGMAC (Ayush)-2024 Round-3 Counselling. Hence they need not to submit fresh Online Application Form.
- 5. As per AACCC letter no. L-14030/137/2022-EP-1 dated 24.10.2024, the candidates who have been included in the ineligible list (i.e. Round-1 admitted, Round-2 admitted and Round-3 allotted) are not eligible for PGMAC (Ayush)-2024 Round-3 Counselling. Hence, they need not submit Fresh Application or Willingness.
- 6. In the light of Adv.No.BCECEB(UGMAC)-2024/01, 2024/02 & 2024/02 dated: 21.09.2024, candidates who have duly submitted the online Application Form and obtained PGMAC ID but has not been allotted any seat on the basis of Round-1 / Round-2 Counselling or have been allotted a seat through Round-1 / Round-2 Counselling but taken free exit and did not participated in Round-2 Counselling or who have been allotted a seat but due to any reason they have not completed the Counselling process also need not to submit fresh online Application Form. If such candidates wants to participate for Round-3 Counselling then they are advised to click the link "Online Application Portal of PGMAC (Ayush)-2024" available on Board's website by login to their account through entering their email ID and Password. After successful login click on "Submit Willingness" button for submitting Willingness. If such candidates want to edit their pre-filled data they may do so before submitting their Willingness.
 - (i) After editing of data if extra payment of Counselling Fee / Security Deposit Amount arises, then candidate will have to pay the balance amount of Counselling Fee / Security Deposit Amount else willingness for participating in Round-3 Counselling will not be considered.
 - (ii) After editing of data if extra payment of Counselling Fee / Security Deposit Amount not arises, then candidate will click on "Submit Willingness" button.
 - (iii) if the candidate do not edit their data then also will have to click on "Submit Willingness" button.
 - **Note :** (i) All such candidates who will give willingness for participating for Round-3 Counselling will have to redownload their Hard Copy (Part-A & Part-B).
 - (ii) All such candidates will have to fill fresh choices for Round-3 Counselling as their previous filled choices will become "Null & Void". Detailed information regarding choice filling / seat allotment result / admission process will be published later on through concerned advertisement.
- 7. Such candidates who have been allotted (Fresh / Retained / Upgraded) seat in Round-2 but due to any reason could not reported to reporting centre for document verification within prescribed date or appeared for document verification but not taken admission on their Round-2 allotted seat, then their paid security deposit amount has been **forfeited** and the allotted seat has been cancelled as well as the candidates who have resigned their Round-2 allotted seat with forfeiture of Security Deposit, their allotted seat has been cancelled and their paid Security Deposit Amount has been **forfeited**.

Such candidate if wants to participate for Round-3 Counselling, then they will have to submit fresh online Application Form with the payment of Counselling Fee / Security Deposit Amount.

- 8. Such candidates who have taken Free Exit or Resigned their Round-2 allotted seat with forfeiture of Security Deposit will have to fill fresh choices for Round-3 Counselling as their previous filled choices will become "Null & Void". Detailed information regarding choice filling / seat allotment result / admission process will be published later on through concerned advertisement.
- 9. Such candidates who have been allotted a seat through Round-2 Counselling and given their upgradation as "Yes" for Round-3 Counselling and completed Document Verification process and have not resigned their Round-2 Allotted seat need not to give their Willingness for Round-3 Counselling. Such candidates shall not have the facility of editing of their pre-filled data. Such candidates will wait for their Round-3 Counselling seat allotment result and will have the facility to modify their choices but will not have the facility to remove their Round-2 allotted choice. Detailed information regarding choice filling / seat allotment result / admission process will be published later on through concerned advertisement.

If any candidates who have been allotted (Fresh / Retained / Upgraded) seat in Round-3 but due to any reason could not

report to reporting centre for document verification within prescribed date or appeared for document verification but do not take admission on their Round-3 allotted seat, then their paid security deposit amount will be **forfeited** and the allotted seat will be cancelled as well as will not be eligible for Stray Vacancy Round Counselling.

- 10. In case of any discrepancies, the Rules and Regulations of AACCC (PG Counselling) / PGMAC (Ayush)-2024 Prospectus for MD / MS (Ayurveda) / MD (Homoeo) / MD (Unani) Courses will be followed.
- 11. Eligibility criteria and instructions and other details are available in the Prospectus of PGMAC (Ayush)-2024 which can be downloaded from the Board's website beeceboard.bihar.gov.in.
- 12. Those candidate who are admitted in any Govt./ Pvt. Ayush Colleges of India up to Round-3 Counselling are not eligible for PGMAC (Ayush)-2024 Round-3 Counselling.
- 13. Seat Matrix of vacancies after completion of 2nd round Counselling will be is available on Board's website from **25.10.2024.** If any further vacancies arises, the Seat matrix of updated vacancies shall be uploaded on the Board's website before start of Round-3 Counselling.
- 14. Procedure for Online Submission of Application Form, procurement of Prospectus and Counselling Fee: The Prospectus for appearing in PGMAC (Ayush) for MD(HOMEO)-2024 can be downloaded Online from the BCECE Board's website: bceceboard.bihar.gov.in by clicking on the link "PGMAC (Ayush)-2024 [MD (HOMEO)]" under Prospectus Section. After that click on "Online Application portal of PGMAC (Ayush) [MD/MS (Ayurveda)/MD (Homoeo)/MD (Unani))]-2024 and follow the instructions appearing on the computer screen.
- I. Step-One Registration: For registering, the candidates are required to fill the information asked in Step-One of the application form, appearing on the computer screen. Candidate must enter their AIAPGET-2024 Roll No. and then click on verify button and then enter their AIAPGET-2024 Application No. & Date of Birth as shown on the screen. If data gets verified, proceed for further process. Candidate while registering, must see that he/ she is giving his/her own email ID and Mobile no. because an OTP will be sent to their entered email ID and mobile no. for email ID and mobile no. verification. After successful verification of email ID and mobile no. and successful registration, the registered mobile no. and email ID can not be changed in the whole process of PGMAC (Ayush)-2024 Counselling in any circumstances. After successful Registration, candidate will receive a message of successful registration on their registered mobile no. and email. After that, candidate will have to login to their account by entering their email ID and Password and will process the further activities to duly submit their online application form. The candidate must keep the password entered in Application Form confidential, otherwise BCECE Board will not be responsible for any changes in their data or any other complication etc. The email ID provided by the candidate during registration will be his "user name".
- II. Step-two (Personal Information): After successful registration and activating the account, the candidate should again "Sign in" to his account and thereafter complete the required entries regarding personal information on the computer screen. Then click on "Save & Continue" button.
- III. Step-Three (Upload Photo and Signature): After entering the personal information, the candidate should upload his / her passport size photograph as uploaded in AIAPGET-2024 online application form and full signature in Hindi and English (Not in capital letter) after duly scanning the same. After uploading photo and signature click on "Save & Continue" button.
- **IV. Step-Four (Educational Information):** After uploading the scanned photo and signature the candidate should enter his / her educational information on the computer screen and click on "Save & Continue" button.
- V. Step Five- (Preview your application): After entering educational information the candidate must verify all the information given by him / her while verifying given information in step-2, step-3 and step-4. If any information is found wrong, then the candidate should click "Back to Edit" button and make required corrections. Thereafter the candidate should click "Save & Continue" button so that entered information should be updated. If preview of application form is found to be correct, then the candidate give his / her Declaration and click the "Proceed to Payment" button so that he / she should pay Counselling Fee as per Step-Six.
- VI. Step-Six (Payment of Counselling Fee and Security Deposit): After previewing the Application Form for submitting the same, candidate should click "Proceed to Payment" button and complete the payment procedure for counselling fee and security deposit according to instruction appeared on the computer screen. Counselling fee is not refundable.
- (a) Candidate has to pay Rs. 2200/-(Two Thousand Two Hundred Only) for all categories i.d. Unreserved/EWS / ST/SC/BC/EBC/DQ candidates as non refundable registration / counselling fee through online mode only e.g. by Credit card/Debit Card/ Net Banking / UPI. The candidate has also to pay processing charge in addition to Counselling Fee for payment through online mode.
- (b) The details of payment of security deposit for Govt. / Pvt. Ayush Colleges will be as follows;

As per above table, the candidate has to pay the refundable security deposit through online mode only e.g. by Credit card/Debit Card/ Net Banking / UPI at the time of registration and submission of the application

form. The candidate has also to pay processing charge in addition to Security Deposit for payment through online mode.

Note: (i) If the amount paid as Examination / Counselling fee is debited from your account but the fee transaction fails, then in such a case you must re-pay the desired full fee and ensure the payment. If your required Registration / Counselling fee / Security Deposit amount do not reflect in Board's account within the due date, your application form will remain incomplete and you will not be eligible for Counselling.

Your failed deducted amount from bank will be refunded to your account.

- VII. Step Seven (Downloading of Part- A & Part-B): After payment of Counselling/Registration Fee and Security Deposit upto scheduled date and time, the candidate must download Hard Copy (Part-A & and Part-B) of online submitted Application Form and keep the same safely in his possession because it contains all informations provided by the candidate and the PGMAC (Ayush)-ID made available by the Board for further use during counselling.
- Note: a. Hard copy of PART-A & PART-B need not to be send to Board's office, but instead this is to be made available at the time of counselling.
 - b. After completing the above procedure and after the date of editing and submitting the online application form, there is no provision for any change or modification in the same.
 - c. The candidate must note that after submission of online application form, neither it can be withdrawn nor any request for refund of paid counselling fee will be entertained.
 - d. Board will not be responsible for any interruption in Internet / Banking system. Therefore the candidates must not wait for last date and complete all procedure before due date.
 - e. If any candidate does the payment of Counselling Fee / Security Deposit, but due to any technical issue the payment does not reflect and the amount got deducted from their bank account and even if due to any technical error sms or mail on their Registered Mobile and email id goes as "Application form submitted successfully" then in this case candidates are advised not to wait for payment updation instead do re-payment of counselling Fee/ Security Deposit else neither your application form nor candidature will be accepted.
 - f. Final Merit list will be prepared after scrutinising the candidate's submitted data from the data provided by AIAPGET/ Health Deptt., Govt. of Bihar.
 - g. The Rank Card / Merit List will be published on the Board's Website on scheduled date as notified through concerned advertisement.
 - h. After online submission of application, if the applicant finds any entries/ photo / signature uploading error has / have been made, then he/ she will have opportunity to edit / rectify the same on the fixed date as notified in concerned advertisement.
 - i. The above mentioned Editing / Rectification / Correction opportunity will be available for only those candidates, who have successfully filled their online application form and make the payment successfully within due date.
 - j. For making Rectification / Correction / Editing in online submitted application, the candidate is required to enter the registered email ID & Password and click on "Sign In" button for getting his account to login where the editing process will be carried out.
 - k. Round-3 Counselling will be also conducted online for which fresh online Registration and Submission of Application Form will be taken from such candidates who have not duly submitted the application form through this advertisement due to any reason. Details will be made available through concerned advertisement.
 - 1. Stray Round Counselling will be also conducted online for which fresh online Registration & submission of application form will be taken. Details will be made available through concerned advertisement.
- 15. DQ candidates must note that they have to submit DQ certificate issued by only authorised Centres / Institutes on prescribed proforma as Annexure-1A of the prospectus of PGMAC(Ayush)-2024 at the time of counselling / document verification. For this, after filling and downloading the hard copy of online application form, candidates must consult any concerned authorised Medical College / Centre / Institute (Annexure-1B & 1C) with the downloaded online application form for disability test for obtaining disability certificate.

Certificate issued from any other Institutes / Centres except above will not be entertained, for which the candidate will himself be responsible.
