**Notice for PGMAC(Ayush)-2024 Special Stray Vacancy Round-III Online Counselling**

1. In the light of Letter of NCISM, Ministry of Ayush Ref NCISM/Examinations/State DME/2024 dt. 08.01.2024 Special Stray Vacancy Round-III, this is to inform all PGMAC(Ayush)-2024 candidates that Special Stray Vacancy Round-III has to be conducted Accordingly that who have duly submitted the online Application Form or Willingness and if found eligible for participating in Special Stray Vacancy Round-II Counselling vide advertisement Adv.No.BCECEB[PGMAC(Ayush)]-2024/27 & 2024/28 dated : 23.12.2024 and were not allotted any seat or not admitted up to Special Stray Vacancy Round-II are only eligible for this Special Stray Vacancy Round-III Counselling.
  2. **All such candidates will have to login to their account of online counselling portal by clicking the link "Online Counselling Portal of PGMAC(Ayush)-2024" available on Board's website and will fresh fill Choices for Special Stray Vacancy Round-III Counselling as their previous filled choices has become "Null & Void". It is mandatory to do Fresh Choice Filling.**
  3. As per AACCC letter dt. 07.01.2025, cut-off percentile for SC / ST category has been reduced by five (05) percentile but as there is no vacancy in SC / ST category in PG (Ayush)-2024 courses, hence no fresh application are being invited for this Special Stray Vacancy Round-III Counselling.
  4. The candidates who are included in the ineligible candidate list uploaded on AACCC website are also not eligible for this Special Stray Vacancy Round-III Counselling.
  5. **The updated Seat Matrix for PGMAC(Ayush)-2024 Special Stray Vacancy Round-III Counselling has been uploaded on Board's Website. The candidate must see it before filling up of their Choices for Online Counselling.**
  6. Candidates are advised to fill choices keeping in mind that virtual vacancy may arises due to upgradation.
  7. Special Stray Vacancy Round-III Counselling will be conducted online.
  8. For Choice filling, candidates are required to do the registration for password creation on counselling portal. Then using their User ID & Password login in their account, candidates have to fill in choices of Course and Institution / Colleges in order of preference. Once choices are filled in, it can be modified before locking it. For this candidates have to click on "Unlock Choices" button after authentication / verification of obtained OTP on their Registered Mobile no. and email, and can modify their choices till last date of choice locking. During the choice locking period it is necessary to lock the choices to get a print of their submitted choices. If candidate does not lock the choice submitted, their choice will be automatically locked on notified date at notified time, however candidate will be allowed to take a print of their choices after locking, but he / she will not be permitted to modify choices after locking.
- Note :** Registration for Choice filling, Choice locking & unlocking process will be done through OTP authentication only which will be sent on Registered Mobile & email of the candidates which can not be changed in any circumstances.
9. The list of finally filled in choices will be sent to candidates on their Registered email ID before seat allotment result.
  10. The candidates who are admitted on any seat can not remove their admitted seat choice from the choice during choice filling but can edit their choices according to their preference.
  11. The seat allotment will be done on merit-cum-choice basis. **Provisional seat allotment order will be made available on Board's website on 12.01.2025.**
  12. All eligible candidates are advised to login their account in schedule period of date & time and view the provisionally allotted seat result and download their provisional allotment order.  

**In case candidate is allotted seat in Special Stray Vacancy Round-III Counselling, he/she has to report physically at reporting centre for Document Verification / Admission as per programme given below and as per rule mentioned in PGMAC(Ayush)-2024 Prospectus.**

The candidates who will be allotted in Special Stray Vacancy Round-III will be treated as admitted candidate and if does not take admission on allotted seat of Special Stray Vacancy Round-III or their seat gets cancelled due to any kind of Discrepancy, their Security Deposit already paid will get **forfeited** as well as will not be eligible for further round counselling (if conducted) and the allotted data will be shared with AACCC as per AACCC rules.
  13. In case of any discrepancies, the Rules and Regulations of AACCC (PG Counselling) / PGMAC(Ayush)-2024 Prospectus will be followed.

15. Those candidate who are admitted in any Govt./ Pvt. Ayush College of India are not eligible for Special Stray Vacancy Round-III Counselling.
