1. Online Application with Choice Filling after Round-2 are invited from such qualified, eligible & interested All India Ayush Post Graduate Entrance Test (AIAPGET)-2025 [Ayurveda] candidates for appearing in the Round-3 Online Counselling of Post Graduate Medical Admission Counselling [PGMAC (Ayush)]-2025 for MD / MS (Ayurveda), who have not done the Registration and submission of Online Application or who has completed their registration process but did not duly submit Online Application with payment of requisite Counselling Fee & Security Deposit against Adv. No. BCECEB[PGMAC(Ayush)]-2025/03 & 2025/04 Dated 26.09.2025 and are not admitted in any Ayush Colleges of India, on the vacant seats of Government/ Private Ayush Colleges of Bihar for admission to the First Year PG Ayush Courses (BAMS) in Government / Private Ayush Colleges of Bihar state based on the Rank of PGMAC(Ayush)-2025 prepared on the basis of merit list of AIAPGET-2025 conducted by the National Testing Agency (NTA) on the basis of vacant seats available after admission on the basis of PGMAC(Ayush)-2025 Online 2nd round counselling held from 31.10.2025 to 01.11.2025.

- (a) MD / MS (Ayurveda) Courses - Aagad Tantra, Ayurveda Sahita, Dravya Guna, Kaya Chikitsa, Rachana Sharir, Ras Shastra, Rog Nidan, Shalakya Eye, Shalakya ENT, Kumarbhritya (Bal rog), Kriya Sharir, Panchakarma, Prasuti evam Stirog, Shalya Tantra, Swasthavritta and Yoga in **Govt. Ayurvedic College, Patna for the session 2025.**
2. Updated Seat Matrix of vacancies after completion of 2nd round Counselling will be available on Board's website from **05.11.2025**. If any further vacancies arises, the Seat Matrix will be updated further and updated vacancies shall be uploaded on the Board's website before start of Round-3 Counselling. **The candidate must see it before filling up of their Choices for Online Counselling.**
3. **Round-3 Counselling will be conducted Online.**
4. **Eligibility criteria, instructions and other details are available in the Prospectus of PGMAC(Ayush)-2025 for MD/ MS (Ayurveda) which can be downloaded from the Board's website bceceboard.bihar.gov.in by clicking on the link "PGMAC(Ayurveda)-2025" under Prospectus Section.**
5. Candidates are advised to fill Online Application or submit their Consent / Willingness by keeping in mind that Virtual Vacancy may arises due to Upgradation.
6. Such candidate who has filled their category **UR / EWS / UR(DQ) / EWS(DQ)** for admission in Private Ayush Colleges of Bihar State but he is a reserved category candidate i.e. BC, EBC, SC, ST and is AIAPGET Qualified then he is eligible for admission in Private Ayush Colleges and he can participate in PGMAC(Ayush)-2025 Counselling.
7. As per AACCC, the candidates who will be included in the ineligible list (i.e. Round-1 admitted, Round-2 admitted and Round-3 allotted) of AIQ will not be eligible for PGMAC(Ayush)-2025 Round-3 and further round of Counselling (if applicable).
8. Such candidates who have registered themselves for PGMAC(Ayush)-2025 but have joined / taken admission on the basis of AIQ (up to Round-2 Counselling) are not eligible for PGMAC(Ayush)-2025 Round-3 and further counselling. **Hence they need not to do Choice Filling for Round-3 Counselling.**
9. Such candidates who have been allotted a seat through Round-3 Counselling of AIQ conducted by AACCC are not eligible for PGMAC(Ayush)-2025 Round-3 and further counselling. **Hence they need not to do Choice Filling for Round-3 Counselling.**
10. In the light of Adv.No.BCECEB[PGMAC(Ayush)]-2025/03 & 2025/04 dated : 26.09.2025 and 2025/13 dated 24.10.2025, candidates who have been allotted a seat and has taken admission by verifying their documents on their respective Seat / Institution on the basis of Round-1 / Round-2 Counselling are not eligible for PGMAC(Ayush)-2025 Round-3 Counselling.

However, 10 (Ten) newly added seats in PG (Ayurveda) courses in RAC, Patna has been updated in the seat matrix uploaded on Board's website, due to which candidates who are admitted through Round-1 or Round-2 counselling are also eligible for Round-3 Counselling of PGMAC(Ayush)-2025. If candidate wants to participate for Round-3 counselling then they must have to submit their consent / willingness and then they may edit / modify their previous filled up choices as per counselling programme schedule mentioned under "Important Dates" **but they will not have the facility to remove/delete their Round-1 or Round-2 Counselling Choice of admitted seat from the choice-list.**

11. For filling Online Application & Choices click on "**Online Portal of PGMAC(Ayurveda)-2025**" and follow the instructions as given below;

i. Step-One (Registration) :

For Registration, candidate will have to authenticate their identity by giving AIAPGET-2025 (Ayurveda) Roll No., Candidate's Name and Date of Birth as appearing on the computer screen. After Identity / Data authentication, an OTP will be sent to candidate's registered Mobile No. and Email Address as provided during submission of AIAPGET-2025 (Ayurveda) Application Form invited by NTA. No request will be entertained to change / update the Mobile No. / Email Address throughout of the session before / after successful Registration. While doing the registration for filling the

online application form, he / she is also required to create password. After successful submission of the Registration details an PGMAC ID will be generated and it will be used to complete the remaining steps of the application form and will also be required for all future reference / correspondence. To complete the remaining steps of the application form candidate will have to login their account by entering their AIAPGET-2025 (Ayurveda) Roll No. & Password and will process the further activities to duly submit their Online Application Form. The candidate must keep the password confidential, otherwise BCECE Board will not be responsible for any consequences.

ii. Step-Two (Multi-Step Application Form) :

(a) Personal Information :

After successful registration, the candidate should again "**Sign in**" to his account and thereafter complete the required entries regarding personal information appeared on the computer screen. Then click on "**Save & Continue**" button.

(b) Contact Details :

After successful completion of Personal Information candidate have to submit their Permanent and Correspondence Address as appeared on the computer screen. Then click on "**Save & Continue**" button.

(c) Educational Information :

After successful completion of Contact Details candidate have to submit their Educational Information as appeared on the computer screen. Then click on "**Save & Continue**" button.

(d) Other Details :

After successful completion of Educational Details candidate have to submit their Other Details as appeared on the computer screen. Then click on "**Save & Continue**" button.

(e) Upload Photo, Signature & Required Documents (if any) :

After successful completion of Other Details candidate have to upload the Scanned copy of their highly contrast Colour Photograph, Signature & Required Documents (if any) at appropriate place as per the instructions provided on the computer screen. Then click on "**Save & Continue**" button. **(For further details kindly refer to the instructions uploaded on application portal regarding Photo & Signature uploading.)**

iii. Step-Three (Application Preview & Final Submit) :

Candidates are advised to check their entries provided in Step-1 & Step-2 of the application form and if found any anomalies, click on "**Back to Edit**" button and rectify it. After rectification click on "**Save & Continue**" button so that the entries provided by them could get updated.

If all the informations provided during filling of Online Application Form found to be OK on the preview page, click on "**Final Submit & Proceed to Payment**" button by giving the declaration and pay the Counselling Fee & Security Deposit as per instruction provided in Step-Four. If candidates does not do the final submission of the application form and payment of Counselling Fee & Security Deposit within prescribed date & time, then their filled up application form will get rejected, for which candidate will be himself solely responsible and no any request will be entertained regarding this.

iv. Step-Four (Payment of Counselling Fee & Security Deposit) :

After clicking "**Final Submit & Proceed to Payment**" button, complete the payment procedure according to instructions appeared on the computer screen regarding payment of Counselling Fee & Security Deposit. **Paid Counselling Fee is not refundable.**

Online Payment : Candidate will have to pay the Counselling Fee & Security Deposit through Online mode only i.e. Debit Card / Credit Card / Net banking / UPI, The candidate has to pay processing charge additional to Counselling Fee & Security Deposit for payment through online mode.

- (a) Candidate has to pay Rs. 2200/- (Two Thousand Two Hundred Only) for Unreserved/ EWS / ST/ SC/ BC/EBC/ DQ candidates as **non refundable** registration / counselling fee through online mode only e.g. by Credit card/Debit Card/ Net Banking / UPI. The candidate has also to pay processing charge in addition to Counselling Fee for payment through online mode.

As per above table, the candidate has to pay the refundable security deposit, if applicable, through online mode only e.g. by Credit card / Debit Card / Net Banking / UPI at the time of registration and submission of the application form. The candidate has also to pay processing charge in addition to Counselling Fee & Security Deposit for payment through online mode.

Note: (i) If the amount paid as Counselling Fee & Security Deposit is debited from your account but the fee transaction fails, then in such case you must re-pay the desired full fee and ensure the payment. If your required Counselling fee & Security Deposit do not reflect in Board's account within the due date, your application form will remain incomplete and will be rejected due to which will not be eligible for participating in the counselling process.

Your failed transaction will be refunded to your account in due course.

v. Step-Five (Choice Filling) :

After successful payment of Counselling Fee & Security Deposit candidate have to fill Choices of course and Institution / Colleges in order of preference. Candidate will have to click on "**Save Choices**" link and after then click on "**Choice Locking**" link to lock their filled up choices before scheduled last date and time. If candidate lock their choices and again want to edit their filled up choices, then candidate may modify their choices by clicking "**Unlock Choices**" link by authentication through their password and OTP sent on their registered Mobile No. / Email ID. Candidates are advised to Lock their filled up choices before scheduled last date and time so that they could download or print their filled up and submitted choices. If candidate click on "**Save Choices**" link but does not lock their filled up choices within scheduled last date and time, their choices will get automatically locked after last date and time of choice filling. Candidate will be allowed to download or take a print of their filled up choices after locking of choices only.

Note : Choice Locking & Unlocking process will be done through OTP authentication only which will be sent on Registered Mobile No. / Email ID of the candidate. **The candidate must note that their Registered Mobile No. and Email ID can not be changed in any circumstances.**

vi. Step-Six (Download Confirmation Page & Fee Receipt) :

After successful payment of Counselling Fee & Security Deposit, candidates are advised to download the Confirmation Page & Fee Receipt and re-verify the entries printed on the confirmation page. **If found any discrepancy it may be corrected during the time of Registration and submission of Application Form-cum-Choice Filling** as per schedule mentioned in "**Important Dates**". Finally download the Confirmation Page for future use.

vii. Step-Seven (Download Choice Slip) :

After successful submission and locking of filled up choices candidate may download or take a print of their filled up choices by clicking "**View Filled Choices**" link available on PGMAC(Ayush)-2025 portal dashboard.

12. Editing / Correction of Application Form Data :

- (i) The above-mentioned editing / rectification / correction opportunity will be available for only those candidates, who have successfully filled their online application form and make the payment successfully within due date.
- (ii) For making rectification / correction / editing in online submitted application, the candidate will have to login to his / her account using their Roll No. & Password provided during the time of Registration. After successful login candidate will click on the link "**Edit your Online Filled Application Form**". Candidate will have to give their consent to Edit / Correct their previous filled Application Form data which will be authenticated through their password and OTP sent on their registered Mobile No. / Email ID. If OTP gets verified, the candidate will be able to edit/correct their filled-up Application Form data and do the following;
 - (a) Candidate may either edit/correct any data of his/her Application or not edit/correct any data of his/her Application Form and save the Application Form finally by clicking "**Final Submit**" button visible on the Preview page of the Application. After Successful submission / Successful updating of payment status on application server, the edited Application Form will be treated as final. The filled-up choices will not get "**Null & Void**" and candidate will have the facility to edit the filled-up choices and to save the choices by clicking "**Save Choices**" link and after that to lock the choices by clicking "**Choice Locking**" link so that printout of finally filled-up and submitted choices could be obtained with proper validation of choices as per eligibility of finally submitted edited data.
 - (b)
 - (i) if candidate either edit/correct any data of his/her Application or does not edit/correct any data of his/her Application Form and does not save the Application Form finally by clicking "**Final Submit**" button visible on the Preview page of the Application, then Application Form will be treated as incomplete and will not be eligible for seat allotment process.
 - (ii) if candidate edit/correct any data of his/her Application **due to which additional fee payment condition arises** then candidate has to pay the required fees but if he/she does not pay the required fee by saving the Application Form finally by clicking "**Final submit**" button visible on the Preview page of the Application, then Application Form will be treated as incomplete and will not be eligible for seat allotment process.

If candidate finally submit the Application successfully in the light of above process, candidate will have the facility to edit the filled-up choices and to save the choices by clicking "**Save Choices**" link and after that to lock the choices by clicking "**Choice Locking**" link so that printout of finally filled-up and submitted choices could be obtained with proper validation of choices as per eligibility of finally submitted edited data.
 - (c) Due to Editing / Correction of data, if any additional Fee payment condition arises then candidate will have to re-pay the desired full-fee of Counselling Fee & Security Deposit afresh and ensure the payment. Such candidate's previously paid amount of Counselling Fee & Security Deposit will be refunded back to their account through the same mode by which they had done the payment.
- (iii) After successful submission of edited Application Form and Filling/Editing of Choices, candidate will have to lock their choices so that they could download or print their filled-up choices.

- (iv) If any candidate locked their filled-up choices and after then wants to Edit / Correct Application Form data, then first of all he / she has to unlock their choices. After Un-Locking of Choices, he / she will click on the link **“Edit your Online Filled Application Form”**.

13.(a) Such candidates who have duly submitted Online Application with payment of requisite Counselling Fee & Security Deposit vide Adv. No. BCECEB[PGMAC(Ayush)]-2025/03 & 2025/04 Dated 26.09.2025 but did not fill their choices due to any reason / have not been allotted any seat for PG courses through Round-1 Counselling/ who have been allotted a seat in PG course through Round-1 Counselling but taken Free-Exit / Resigned their allotted seat as well as not participated in Round-2 Counselling or Participated in Round-2 Counselling but has not been allotted any seat in PG Course, if wants to participate in Round-3 Counselling then they have to login to their account with their AIAPGET-2025 Roll No. and Password by clicking the link **“Online Portal of PGMAC(Ayurveda)-2025”** available on Board’s Website and will have to give their Consent/Willingness.

(b) Such candidates who have been allotted any seat in PG Courses through Round-2 Counselling but as per rule their paid Security Deposit amount gets forfeited due to any reason, if wants to participate in Round-3 Counselling then they have to login to their account with their AIAPGET-2025 Roll No. and Password by clicking the link **“Online Portal of PGMAC(Ayurveda)-2025”** available on Board’s Website and will have to give their Consent / Willingness with fresh payment of Counselling Fee & Security Deposit.

Note : Such candidates who have been allotted any seat in PG Courses through AIQ Round-2 Counselling and taken Resignation vide Adv. No. BCECEB[PGMAC(Ayush)]-2025/10 Dated 16.10.2025, if wants to participate in Round-3 Counselling then they have to login to their account with their AIAPGET-2025 Roll No. and Password by clicking the link **“Online Portal of PGMAC(Ayurveda)-2025”** available on Board’s Website and will have to give their Consent / Willingness with fresh payment of Counselling Fee & Security Deposit.

All such candidates who will give Consent / Willingness to participate in Round-3 Counselling, will have the facility to Edit / Modify their previous filled-up Choices but who have taken the resignation will have to fill Fresh Choices as their Choices has become **“Null & Void”**, whether he/she Edit / Correct their previous filled Application Data or Not. If candidate who have taken resignation and don’t fill Fresh Choices after their previous choices becoming **“Null & Void”**, will not be eligible for seat allotment process for which candidate will themselves solely responsible. After filling of fresh choices, candidates are advised to kindly lock their choices.

It is mandatory to fill Choices else candidate will not be eligible for seat allotment process.

14. Such candidates who have been allotted a seat in PG Courses through Round-2 Counselling and given their Upgradation as **“YES”** for Round-3 Counselling and successfully completed their Round-2 Counselling Document Verification process with no any discrepancy will have to login to their account with their AIAPGET-2025 Roll No. and Password by clicking the link **“Online Portal of PGMAC(Ayurveda)-2025”** available on Board’s Website and will have to give their Consent / Willingness.

(a) All such candidate who will give their Consent / Willingness to participate in Round-3 Counselling, their all previous filled choices will remain available in their choice list i.e. their previous filled choices will not become **“Null & Void”**. **The candidate will have the facility to edit their choices but will not have the facility to remove/delete their Round-2 Counselling allotted choice from the choice-list.**

(b) If candidate has given their Upgradation as **“YES”** for Round-3 Counselling and successfully completed their Round-2 Counselling Document Verification process with no any discrepancy but did not give their Consent / Willingness for Round-3 Counselling by following above process, they will be eligible for Round-3 Counselling on their previous filled choices only. **The candidate will not have the facility to edit their choices.**

15. Consent / Willingness will be authenticated through Login password and OTP sent on their registered Mobile No. / Email ID.

16. If candidate wants to edit their previous filled Application form Data by giving their Consent / Willingness to participate in Round-3 Counselling, candidates are advised to see the section **“Editing / Correction of Application Form Data”** of this advertisement.

17. During Editing / Correction of Application Form data, candidate will not be allowed to edit their data like Name, Father’s Name, Mother’s Name, Date of Birth, Gender, DQ, Mobile No., Email ID, Proof of Identity and Identity No. etc.

18. Such candidates who have been allotted a seat in PG Courses through Round-2 Counselling and given their Upgradation as **“YES”** for Round-3 Counselling and successfully completed their Round-2 Counselling Document Verification process with no any discrepancy will not have the **facility to edit / correct their previous filled Application Form data in any circumstances.**

19. Final Merit list will be prepared after scrutinising the data of AIAPGET-2025 provided by NCISM, New Delhi. On the basis of AIR obtained in AIAPGET-2025 (Ayurveda), Rank Card of all eligible candidates who will fill Online Application Form and pay the Counselling Fee & Security Deposit in **between 10.11.2025 to 13.11.2025** will be uploaded on Board's website **“bceceboard.bihar.gov.in”** on **15.11.2025**. Candidates are advised to download their Rank Card of AIAPGET-2025 (Ayurveda) by clicking the link **“Rank Card of PGMAC(Ayurveda)-2025”** by submitting their PGMAC ID and Date of Birth.

20. a. The candidates are required to fill up the reservation category very carefully taking into consideration the reservation policy/ rules / category as specified and applicable in the State of Bihar on or before the date of starting the process of online submission of the prescribed application form for PGMAC(Ayush)-2025. Details of Reservation Rule may be seen in Para-6 of PGMAC(Ayush)-2025 (Ayurveda) Prospectus.

- b. Confirmation Page (Application Form) need not to be send to Board's office, but instead this is to be made available at the time of counselling.
 - c. After completing the above procedure and after the date of editing and submitting the online application, there is no provision for any change or modification in the same.
 - d. **The candidate must note that after submission of online application, neither it can be withdrawn nor any request for refund / chargeback of paid counselling fee will be entertained.**
 - e. Board will not be responsible for any interruption in Internet / Banking system. Therefore the candidates must not wait for last date and complete all procedure before due date.
 - f. No other chance will be given to any candidate for Registration and submission of online application after due date for online submission of application.
21. DQ candidates must note that they have to submit DQ certificate issued by only authorised Centres / Institutes on prescribed proforma as per para-6(B) (Annexure-1A, 1B, 1C) of the prospectus of PGMAC(Ayush)-2025 at the time of counselling / document verification. For this, after filling and downloading the hard copy of online application, candidates must consult any concerned authorised Medical College / Centre / Institute with the downloaded online application form for disability test for obtaining disability certificate.
- Certificate issued from any other Institutes / Centres except above will not be entertained, for which the candidate will himself be responsible.**
22. The list of finally filled choices will be sent to candidates on their Registered email ID before seat allotment result.
23. The seat allotment will be done on merit-cum-choice basis. All eligible candidate are advised to login into their account as per schedule and view the provisionally allotted seat result and download their provisional allotment order.
24. **If any candidates who have been allotted (Fresh / Retained / Upgraded) seat in Round-3 but due to any reason could not report to reporting centre for document verification within prescribed date or appeared for document verification but do not take admission on their Round-3 allotted seat or found not eligible during document verification due to any discrepancy, then their paid Security Deposit amount will be forfeited and the allotted seat will be cancelled as well as will not be eligible for Stray Vacancy Round Counselling.**

Colleges have high Fee structure, therefore candidates must confirm the Fee structure before Registration & Submission of Application-cum-Choice Filling from either the website of BCECE Board or concerned colleges. BCECE Board takes no responsibility of the fee structure of the colleges and will not entertain any complaint regarding Fee structure.

28. Candidates must note that Online filling of Application form / Registration for admission in Ayush Course shall be done once only on the basis of which seat allotment of Round-3 of counselling will be done. No other opportunity will be provided in between Round-3 for Online Registration and Submission of Application under any condition.
29. In case of any discrepancies, the Rules and Regulations of AACCC (PG Counselling) / PGMAC(Ayush)-2025 [Ayurveda] Prospectus will be followed.
30. Candidates are advised to go through the PGMAC(Ayurveda)-2025 Prospectus in detail.
