**Notice for Round-3 Online Counselling**

In continuation to the advertisement no.-BCECEB(PGDAC)-2023/01 & 2023/02 dated 02.08.2023 , 2023/07 & 2023/08 dated 24.09.2023 and 2023/09 dated 26.09.2023, Rank Cards of all eligible candidates who have filled their online registration form successfully and paid the registration fee as well as security deposit in between 26.09.2023 to 30.09.2023 have been uploaded on Board's website. Candidates are advised to download their Rank Card of PGDAC-2023 by clicking the link "**Rank Card of Round-3 Counselling of PGDAC-2023**" by submitting their PGDAC ID and Date of Birth.

After downloading the rank card, candidates have to do choice filling for online counselling. For online choice filling, all eligible candidates are required to click on link "**Online Counselling Portal of PGDAC-2023**".

2. The updated Seat Matrix for PGDAC-2023 Counselling has been uploaded on Board's Website.
3. Those candidates who are admitted through Round-1 or Round-2 counselling of PGDAC-2023 / Counselling conducted through MCC or Allotted a seat through Round-3 counselling of MCC are not eligible for Round-3 Counselling of PGDAC-2023.
4. Such candidates who have duly submitted their online Application Form by depositing the Security Deposit for attending the Counselling of PGDAC-2023 or who has Re-paid the Security Deposit Amount against Advertisement No. BCECEB(PGDAC)-2023/07 dated 24.09.2023 and 2023/09 dated 26.09.2023 or such candidates who have not been allotted any seat through Round-1 / Round-2 Counselling or who has taken Free Exit from Round-1 Counselling but did not allotted any seat in Round-2 or Allotted a seat through Round-2 Counselling and taken Exit with or without forfeiture of Security Deposit are eligible for Round-3 Counselling.
5. For Round-3 Counselling, All eligible candidates will click on the link "**Online Counselling Portal of PGDAC-2023**" and there after login to their account through Counselling portal can do Fresh Choice Filling / Edit their Choices.
6. Such candidates who have taken Free Exit through Round-1 Counselling and have not done Fresh Choice Filling or who have taken Exit without forfeiture of Security Deposit / Exit with forfeiture of Security Deposit through Round-2 Counselling, their previous filled choices became "Null & Void" i.e. for attending Round-3 Counselling, **it is mandatory to do Fresh Choice Filling.**
7. Such candidates who have been allotted a seat through Round-2 Counselling and given their upgradation as "Yes" for Round-3 counselling and completed Document Verification process, they can also edit their previous filled choices but cannot delete their Round-2 allotted Choice from the choice list.
8. For Choice filling, candidates are required to do the registration for password creation on counselling portal. Then using their User ID & Password login in their account, candidates have to fill in choices of Course and Institution / Colleges in order of preference. Once choices are filled in, it can be modified before locking it. For this candidates have to click on "Unlock Choices" button after authentication / verification of obtained OTP on their Registered Mobile no. and email, and can modify their choices till last date of choice locking. During the choice locking period it is necessary to lock the choices to get a print of their submitted choices. If candidate does not lock the choice submitted, their choice will be automatically locked on notified date at notified time, however candidate will be allowed to take a print of their choices after locking, but he / she will not be permitted to modify choices after locking.

Note : Registration for Choice filling, Choice locking & unlocking process will be done through OTP authentication only which will be sent on Registered Mobile & email of the candidates which can not be changed in any circumstances.

9. The list of finally filled in choices will be sent to candidates on their Registered Mobile no. & email before seat allotment result.
10. The seat allotment will be done on the basis of merit-cum-choice basis. Merit list and Rank Card for Round-3 Provisional Seat Allotment Order will be made available on Board's website **on 07.10.2023.**
11. All eligible candidates are advised to login their account in schedule period of date & time and view the provisionally allotted seat result and download their provisional allotment order.

In case candidate is allotted seat during Round-3 seat allotment, he/she has to report physically at reporting centre for Document Verification. After document verification if he is found eligible will take admission as per programme given below and as per rule mentioned in PGDAC-2023 Updated Prospectus.

12. Updated seat matrix of Govt. and Pvt. Medical / Dental Colleges and Veterinary Colleges of Bihar have already been uploaded on Board's website. The candidates must see it before filling up of their Choices for Online Counselling.
