Notice for PGDAC-2023 Stray Vacancy Round Online Counselling

In continuation to the advertisement no.-BCECEB(PGDAC)-2023/11 & 2023/12 dated 12.10.2023, Rank Card of all eligible candidates who have filled their online registration form successfully and paid the registration fee as well as security deposit in between 13.10.2023 to 15.10.2023 have been uploaded on Board's website. Candidates are advised to download their Rank Card of PGDAC-2023 by clicking the link **"Rank Card of Stray Vacancy Round Counselling of PGDAC-2023"** by submitting their PGDAC ID and Date of Birth.

After downloading the rank card, candidates have to do choice filling for online counselling. For online choice filling, all eligible candidates are required to click on link **"Online Counselling Portal of PGDAC-2023"**.

2. **The Seat Matrix for PGDAC-2023 Stray Vacancy Round Counselling has been uploaded on Board's Website.** The candidates must see it before filling up of their Choices for Online Counselling.

3. **All candidates who are eligible for Stray Vacancy Round Counselling have to do Fresh Registration-cum-Choice Filling as all previous filled Choices has become null and void.**

4. For Choice filling, candidates are required to do the registration for password creation on counselling portal. Then using their User ID & Password login in their account, candidates have to fill in choices of Course and Institution / Colleges in order of preference. Once choices are filled in, it can be modified before locking it. For this candidates have to click on "Unlock Choices" button after authentication / verification of obtained OTP on their Registered Mobile no. and email, and can modify their choices till last date of choice locking. During the choice locking period it is necessary to lock the choices to get a print of their submitted choices. If candidate does not lock the choice submitted, their choice will be automatically locked on notified date at notified time, however candidate will be allowed to take a print of their choices after locking, but he / she will not be permitted to modify choices after locking.

Note : Registration for Choice filling, Choice locking & unlocking process will be done through OTP authentication only which will be sent on Registered Mobile & email of the candidates which can not be changed in any circumstances.

5. The list of finally filled in choices will be sent to candidates on their Registered email ID before seat allotment result.

6. The seat allotment will be done on the basis of merit-cum-choice basis. Stray Vacancy Round Provisional Seat Allotment Result will be available on Board's website **on 19.10.2023**.

7. All eligible candidates are advised to login their account in schedule period of date & time and view the provisionally allotted seat result and download their provisional allotment order.

8. The candidates who will be allotted in Stray Vacancy Round will be treated as admitted. If candidate does not take admission on allotted seat of Stray Vacancy Round, their Security Deposit Amount will be forfeited and the allotted data will be shared with MCC as per MCC updated rules.
