Notice for Online Counselling

In continuation to the advertisement no.-BCECEB(PGDAC)-2024/01 & 2024/02 dated 07.07.2024, Rank Card of all eligible candidates who have filled their online registration form successfully and paid the registration fee as well as security deposit in between 09.07.2024 to 14.07.2024 have been uploaded on Board's website. Candidates are advised to download their Rank Card of PGDAC-2024 by clicking the link "**Rank Card of PGDAC-2024**" by submitting their PGDAC ID and Date of Birth.

After downloading the rank card, candidates have to do online Registration-cum-choice filling for online counselling. For online choice filling, all eligible candidates are required to click on link "**Online Counselling Portal of PGDAC-2024**". After clicking the link candidates are advised to do the registration for online counselling by submitting the data as asked on the computer screeen.

2. The Seat Matrix for PGDAC-2024 Counselling has been uploaded on Board's Website.

3. After successfull Online Registration for online counselling candidate will login to their account using their user ID & Password and will fill in choices of Course and Institution / Colleges in order of preference. After choices are filled in and locked, candidates may modify their choices by clicking "**Unlock Choices**" button by authentication through OTP sent on their registered Mobile no. and email. During the choice locking period it is necessary to lock the choices to get a print of their submitted choices. If candidate does not lock the choice submitted, their choice will be automatically locked on notified date & time. However candidate will be allowed to take a print of their choices after locking.

Note : Registration, Choice locking & unlocking process will be done through OTP authentication only which will be sent on Registered Mobile & email of the candidates. **The candidates must note that their Registered Mobile No. and email ID can not be changed in any circumstances.**

4. The list of finally filled choices will be sent to candidates on their Registered email before seat allotment result.

5. The seat allotment will be done on merit-cum-choice basis. Provisional seat allotment order will be made available on Board's website on 23.07.2024.

6. All eligible candidate are advised to login their account on schedule period of date & time and view the provisionaly allotted seat result and download their provisional allotment order. If the candidate is not satisfied with their allotted seat, they must select up-gradation "**Yes**" in the process of downloading the Provisional Allotment Order of 1st round.

In case candidate is allotted seat during 1st round seat allotment, he/she has to report physically at reporting centre for Document Verification. After document verification if he is found eligible, will take admission as per programme given below and as per rule mentioned in PGDAC-2024 Prospectus. Incase if he/she has given willingness for upgradation during downloading of 1st round provisional seat allotment order then he/she has to also appear for document verification at their reporting centre. Their submitted documents will be retained at reporting centre and he/she will wait for 2nd Round seat allotment result. Other details regarding online counselling are available in the Prospectus of PGDAC-2024.

If any candidate gets allotted through Round-2 Counselling has to Report physically at reporting centre for ducument verification and to take the admission to their allotted Seat / Institution as printed on the Round-2 Provisional Allotment Order as per the programme given below. **If candidate fails to take admission then in such case their paid Sucurity Deposit will get forfeited.**
