Fresh Online registration and submission of Application form are invited from such qualified, eligible and interested NEET-MDS 2024 candidates who have not duly submitted the Online Application Form against Adv.No.BCECEB(PGDAC)-2024/01 & 2024/02 dated : 07.07.2024 and 2024/06 & 2024/07 dated : 09.08.2024 for admission in Govt. as well as Pvt. Dental Colleges of Bihar on vacant seats of MDS Courses after admission on the basis of PGDAC-2024 Round-3 Counselling which was held from 26.08.2024 to 28.08.2024 vide Adv. No.-BCECEB(PGDAC)-2024/08 dated 17.08.2024.

2. Stray Round Vacancy Counselling will be conducted Online.
3. The candidates who fall under below mentioned conditions need not to submit Fresh Online Application Form as they are not eligible to participate in Stray Vacancy Round Counselling of PGDAC-2024 based on NEET(MDS)-2024:
 - (a) Admitted on MDS seat through PGDAC-2024 Round 1 / Round 2 Counselling.
 - (b) Admitted through AIQ on the basis of NEET(MDS)-2024 Round 1 / Round 2 Counselling.
 - (c) Allotted through AIQ on the basis of NEET (MDS)-2024 Round-3 Counselling.
 - (d) Admitted through NEET(MDS)-2024 Round 1 / Round 2 / Round-3 / Stray Vacancy Round Counselling conducted by Other States (if applicable).
 - (e) Allotted through AIQ on the basis of NEET(MDS)-2024 Stray Vacancy Round Counselling.
If any candidate duly submits fresh Online Application form by providing wrong information, their Security Deposit amount paid for participating in Stray Vacancy Round Counselling will be forfeited and will become not eligible for Stray Vacancy Round Counselling as Data will be scrutinized before preparation / publication of Merit List.
4. The online Willingness / Registration and submission of Application Form will **start from 31.08.2024 and close on 02.09.2024 (10.00 P.M.)** .
