**Notice for Stray Vacancy Round Online Counselling**

In pursuant to the public Notice of Ministry of Health & Family Welfare (Dental Education) Govt. of India, New Delhi Letter No. V.12025/84/2024-DE dt. 10.08.2025 regarding lowering down the qualifying cut-off percentile for NEET(MDS)-2025 by 19.863 percentile for each category, fresh Online registration and submission of Application are invited from such qualified, eligible and interested NEET(MDS)-2025 candidates for admission in Govt. as well as Pvt. Dental Colleges of Bihar on vacant seats of MDS Courses after admission on the basis of PGDAC-2025 Round-3 Counselling, which was held from 18.08.2025 to 19.08.2025 vide Adv. No.-BCECEB(PGDAC)-2025/07 dated 07.08.2025.

2. Seat Matrix of vacancies after completion of Round-3 Counselling will be available on Board's website from **23.08.2025**. If any further vacancies arises, the Seat matrix of updated vacancies shall be uploaded on the Board's website before start of Stray Vacancy Round Counselling. **The candidate must see it before filling up of their Choices for Online Counselling.**

3. Stray Round Vacancy Counselling will be conducted Online.

4. In the light of Adv. No. BCECEB(PGDAC)-2025/01 & 2025/02 dated 07.08.2025 and 2025/07 Dated: 07.08.2025 who have duly filled the online Application for PGDAC-2025 and fall under below mentioned conditions are **not eligible** to participate in Stray Vacancy Round Counselling of PGDAC-2025 based on NEET(MDS)-2025. Hence they need not to submit online Application nor Consent / Willingness.

- (a) Admitted on PG Dental seat through PGDAC-2025 Round-1 / Round-2 Counselling.
- (b) Allotted through PGDAC-2025 Round-3 Counselling.
- (c) Admitted through AIQ on the basis of NEET(MDS)-2025 Round-1 / Round-2 / Round-3 Counselling.
- (d) Allotted through AIQ on the basis of NEET(MDS)-2025 Stray Vacancy Round Counselling.
- (e) Any other under not eligible criterias as mentioned in previous round of concerned Counselling Advertisement.

5. The online Consent / Willingness / Registration and submission of Application will **start from 25.08.2025 and close on 31.08.2025 (10.00 pm)**.
