NOTICE for PGEAC-2024 Second Counselling

In continuation to the Adv. No.- BCECEB(PGEAC)-2024/04 & 2024/05 Dated 13.11.2024, it is to inform all concerned related to PGEAC-2024 that the candidates who are qualified and eligible on the basis of the prospectus of Post Graduate Engineering Admission Counselling (PGEAC)-2024 and who have duly submitted the online application form / Willingness in response to Adv. No.- BCECEB(PGEAC)-2024/04 Dated 13.11.2024 are included in the counselling programme for seat allotment against the vacant seats after the First counselling held from 12.09.2024 to 19.09.2024 as per Adv. No.- BCECEB(PGEAC)-2024/03 Dated 09.09.2024.

2. Each eligible candidate who is included in merit list has to appear for counselling on the scheduled date/ time along with the print copy of already 'online' filled Part-A and Part-B application form, the original certificates / documents as per the prospectus of PGEAC-2024. After verification of certificates / documents/ identity, the course / institution will be allotted merit / rank wise to eligible candidates as per prospectus of PGEAC-2024.

3. The PGEAC-ID of reserve category candidates who competed in Unreserved (UR) category have been included in UR as well as their respective reserve categories. **Therefore, reserved category candidates who are included in UR Category must come for counselling on the date and time fixed for the same at their UR merit serial for option of course / institution available in UR category failing which the seat available at that UR merit will be allotted to candidates of lower merit for which candidate will be himself responsible. This is to be noted that as per reservation policy seats of UR category which will be blocked due to such jump over, that will be opened only on the day of the respective category counselling.**

6. It is to be noted that firstly the available seats shall be filled up by "GATE Qualified candidates" as per para 6(ii).
after that if the seats remain vacant, then "Non GATE (BE / B.Tech.) candidates" shall be called for seat allotment as per para 6(iii).

7. All the certificates included in the list given below, **if applicable**, must be submitted in original by every candidate at the time of his/ her Counselling / Allotment on the scheduled date. **In case of reshuffle, Admitted candidates through PGEAC-2024 1st round Counselling has to bring Admission Receipt and bonafide certificate from the Principal of concerned Institute that he is a bonafide student of the Institute and following document (List of Documents) is deposited in the Institution;**

- (i) Gate Score Card (if applicable)
- (ii) Rank Card of PGEAC-2024 for 2nd counselling.
- (iii) Passing Certificate / Marks Sheet / Admit Card of Matric / Equivalent Examination.
- (iv) Passing Certificate / Marks Sheet / Admit Card of Intermediate Sc. / Equivalent Examination.
- (v) Passing Certificate / Marks Sheet of B.E. / B.Tech of all year / semester.
- (vi) CGPA to Percentage Conversion Certificate by concerned Institution (if applicable).
- (vii) Certificate for Residence of of Bihar duly issued by concerned C.O. countersigned by DM / SDO (Civil) of Permanent Residence.
- (viii) Caste Certificate duly issued by Concerned C.O. of Permanent Residence.
- (ix) Physically disabled certificate, if applicable

 - (xii) Migration Certificate
 - (xiii) Any other required certificate / documents as per prospectus of PGEAC-2024.
 - (xiv) Six copies of passport size photograph which were uploaded during filling of Online Application Form.
 - (xv) Copy of Aadhar Card.
 - (xvi) Downloaded Print of Online filled Application Form (Part-A and Part-B) PGEAC-2024.
 - (xvii) The Verification Slip (जाँच-पत्ती) in 2 copies and Biometric Form one copy as downloaded.
8. Inclusion of any PGEAC - ID in the above Counselling/ Interview programme does not guarantee admission. Candidates in excess of the available seats are being called for Counselling / Interview in order to ensure filling up vacancies which may arise due to absentees.
9. Rank Card of PGEAC-2024 for 2nd Counselling has been uploaded on Board's website bceceboard.bihar.gov.in in which can be obtained by clicking the Link "Download Rank Card of PGEAC-2024 for 2nd Counselling" using his / her PGEAC ID and Date of Birth.
10. If a candidate called for Counselling / Interview is found ineligible as per the requirements of the prospectus of PGEAC-2024 and / or the latest order/ orders passed by the Hon'ble High Court/ Supreme Court or Department of Science & Technology in matters related to PGEAC-2024, his / her candidature is liable to be rejected.
11. Each eligible candidate will be allowed to exercise his/ her option for Course/ Institution from amongst those available at his/ her merit serial after his/ her original Certificates/ Documents and identity are verified.
12. A candidate who absents or fails to appear on the scheduled date & time of his/ her Counselling/Interview may appear for Counselling any time during the period of Counselling of his/her respective category, but in that case he/ she will have the option of Course/ Institution available at the time of his/ her actual reporting on allotment table.
13. Each candidate should note that once the Course/ Institution is opted at the time of his/ her Counselling in his/ her concerned category for which his/ her choice is allowed and the same is allotted to him/ her, no subsequent request for change of course and/ or Institution in the same category shall be entertained.
14. Admission fee and other related charges shall have to be deposited at the time of admission in the concerned college.
15. In case of dispute, decision of the Controller of Examination, BCECEB shall be final.
16. The Department of Science & Technology, Govt. of Bihar and the Bihar Combined Entrance Competitive Examination Board reserve the right to amend the rules relating to PGEAC-2024.
