In continuation to Adv. No.- BCECEB(PGEAC)-2026/01 & 2026/02 Dated 07.07.2026, it is to inform all concerned related to PGEAC-2026 that the candidates who are qualified and eligible on the basis of the prospectus of Post Graduate Engineering Admission Counselling (PGEAC)-2026 and who have duly applied in response to Adv. No.- BCECEB(PGEAC)-2026/01 & 2026/02 Dated 07.07.2026 are included in the counselling programme for allotment of M. Tech. Course in the following Govt. Engineering Colleges of Bihar;

M.I.T., Muzaffarpur / B.C.E., Bhagalpur / G.E.C., Vaishali / G.C.E., Gaya / K.C.E., Katihar / G.E.C.,
West Champaran/ Supaul College of Engg., Supaul / Sri Phaneshwar Nath Renu Engg. College, Araria
/ N.C.E., Chandil/ D.C.E., Darbhanga / Bihar Remote Sensing Application Centre, Patna.

2. Each eligible candidate who is included in merit list has to appear for counselling on the scheduled date & time alongwith the printed copy of already filled online application (Confirmation Page), the original certificates / documents as per the prospectus of PGEAC-2026. After verification of certificates / documents/ identity, the course / institution will be allotted on Merit-cum-Choice basis to eligible candidates as per prospectus of PGEAC-2026.

3. The PGEAC-ID of reserve category candidates who competed in Unreserved category have been included in Unreserved (UR) category as well as in their respective reserved categories. The seat of reserved category will remain open during the counselling of UR category and Reserved Category candidates present in UR merit list will have option to opt UR seat as well as there category seat. **Therefore, Reserve Category (RC) candidates who are included in Unreserved Category must come for counselling on the date fixed at their Unreserved Category merit serial for option of course / institution available in Unreserved category as well as reserve category**, otherwise the reserved category seat available at their merit Serial may be opted and allotted to the candidate of lower merit for which be they themself could be responsible. This is to be noted that as per reservation policy, Seats of UR category, which will be blocked due to such jump over, will be opened only on the day of the respective categories counselling.

4. The counselling / Interview will be held at the office of Bihar Combined Entrance Competitive Examination Board, IAS Association Building, Near Patna Airport, Patna-14.

7. Inclusion of any PGEAC - ID in the above Counselling/ Interview programme does not guarantee admission. Candidates in excess of the available seats are being called for Counselling / Interview in order to ensure filling up vacancies which may arise due to absentees.

8. Rank Card of PGEAC-2026 has been uploaded on Board's website bceceboard.bihar.gov.in in which can be obtained by clicking the Link "Download Rank Card of PGEAC-2026" using his / her PGEAC ID and Date of Birth.

9. If a candidate called for Counselling / Interview is found ineligible as per the requirements of the prospectus of PGEAC-2026 and / or the latest order/ orders passed by the Hon'ble High Court/ Supreme Court or Department of Science, Technology & Technical Education in matters related to PGEAC-2026, his / her candidature is liable to be rejected.

10. Each eligible candidate will be allowed to exercise his/ her option for Course/ Institution from amongst those available at his/ her merit serial after his/ her original Certificates/ Documents and identity are verified.

11. A candidate who absents or fails to appear on the scheduled date & time of his/ her Counselling/Interview may appear for Counselling any time during the period of Counselling of his/her respective category, but in that case he/ she will have the option of Course/ Institution available at the time of his/ her actual reporting on allotment table.

12. Each candidate should note that once the Course/ Institution is opted at the time of his/ her Counselling in his/ her concerned category for which his/ her choice is allowed and the same is allotted to him/ her, no subsequent request for change of course and/ or Institution in the same category shall be entertained.
13. Admission fee and other related charges shall have to be deposited at the time of admission in the concerned college.
14. In case of dispute, decision of the Controller of Examination, BCECEB shall be final.
15. The Department of Science, Technology & Technical Education Deptt., Govt. of Bihar and the Bihar Combined Entrance Competitive Examination Board reserve the right to amend the rules relating to PGEAC-2026.
