No. BCECEB(PGEAC)-2026/05 & 2026/06 Dated 31.07.2026 for participating in the Round-3 Counselling of Post Graduate Engineering Admission Counselling (PGEAC)-2026 on the vacant seats of PGEAC-2026 after Round-2 Counselling of Non GATE qualified candidates as per seat matrix uploaded on Board's website.

2. This Counselling is only for Non GATE Candidates.

3. Such Non GATE candidates who have duly submitted / filled the Online Application Form earlier as per Adv. No.- BCECEB(PGEAC)-2026/05 & 2026/06 Dated 31.07.2026 and Admitted / Not Admitted in any colleges or Absent due to any reason in Round-2 counselling of PGEAC-2026 but wants to participate for PGEAC-2026 Round-3 Counselling on the vacant seat of PGEAC-2026 as per seat matrix uploaded on Board's website will give their Consent / Willingness by login to their account by clicking the link "Online Application Portal of PGEAC-2026".

Such Non GATE candidates who are admitted through Round-2 Counselling of PGEAC-2026 and if he/she submits Willingness for participating in Round-3 Counselling of PGEAC-2026, will have to submit admission slip as well as Bonafide Certificate issued from their admitted college regarding submission of their Original documents during the time of document verification / counselling process of Round-3 Counselling of PGEAC-2026.

5. Such Non-GATE candidate who had participated in Round-2 Counselling but due to discrepancy in B.E./ B.Tech. Passed percentage, they have not been allotted the seat during Document Verification may participate in this Round-3 Counselling by giving their Consent / Willingness and by editing their Percentage / Marks in Application form data. After editing of data candidate must their application form finally and must download and check their Confirmation Page regarding updation of edited data.

6. The online Registration and submission of Online Application Form / Consent / Willingness will start from 02.09.2026 and close on 06.09.2026 (10.00 P.M.).
