NOTICE for 2nd MOP UP COUNSELLING

The list of qualified candidates of NEET-PG 2019 which has been provided by National Board of Examination (NBE) / Health Department, Govt. of Bihar for admission to first year of the Post Graduate Degree / Diploma courses in Govt. / Private Medical colleges of Bihar State is already uploaded on Board's website (bceceboard.bihar.gov.in).

The category wise minimum percentile criteria is revised for NEET-PG 2019 by NBE, New Delhi vide Public Notice dt. 08.05.2019. According to which the candidates who obtained minimum 44th percentile for Unreserved (General), 34th percentile for SC/ ST/ OBC & 39th percentile for PWD (DQ) will be considered eligible for the 2nd Mop Up Counselling. Therefore, Online application on prescribed form are invited from NEET-PG 2019 qualified interested candidates from 13.05.2019 to 15.05.2019 (11.59 P.M.) on the basis of the above mentioned list for appearing in the 2nd Mop Up round of Post Graduate Medical Admission Counselling (PGMAC)-2019 in order to select candidates for admission against vacant state quota seats in the **FIRST YEAR** of the following Post Graduate Degree Courses ;

- (i) MD / MS / PG Diploma (PGD) Courses in Govt. Medical Colleges eg. Patna Medical College, Patna , Darbhanga Medical College, Darbhanga , Nalanda Medical College, Patna , A.N.M. Medical College, Gaya, J.L.N.M.C., Bhagalpur, S.K.M.C., Muzaffarpur and IGIMS Medical College, Patna for the session 2019.
- (ii) MD / MS / PG Degree Courses in Private Medical Colleges eg. K.M.C., Katihar, Narayan Medical College & Hospital, Sasaram, M.G.M.M.C., Kishanganj for the session 2019.

The available vacant seat (State Quota seat) position will be uploaded on the Board's website bceceboard.bihar.gov.in on the day of start of counselling.

2.(a) Eligibility criteria for counselling, Fee payment procedure, instructions and other details are available in the prospectus of PGMAC-2019 and the related Advertisement No. BCECEB(PGMAC)-2019/01 , 2019/02 dt. 30.03.2019 and 2019/10 dt. 06.05.2019 which can be downloaded from the Board's website bceceboard.bihar.gov.in .

2.(b) Those candidates who have already duly submitted complete online application form in response to Advertisement no. BCECEB(PGMAC)-2019/01, 2019/02 Dated : 30.03.2019 , 2019/03 Dated : 03.04.2019 and 2019/08 , 2019/09 Dated 02.05.2019 respectively and whose name and PGMAC-ID is already included in the merit list published on 24.04.2019 on BCECEB website and counselling programme published vide Adv. no. BCECEB(PGMAC)-2019/10 Dated : 06.05.2019 **need not apply again.** Fresh merit list for 2nd Mop Up counselling will be published on 16.05.2019.

3. Procedure for Online Submission of Application Form, procurement of Prospectus and Counselling Fee : The Prospectus for appearing in PGMAC-2019 can be downloaded Online from the BCECE Board's website : bceceboard.bihar.gov.in by clicking on the link "**PGMAC-2019**" under Prospectus Section. After that click on '**Apply for PGMAC-2019 (2nd Mop Up Counselling)**' button and follow the instructions appeared :

I. Step-One - Registration : For registering, the candidate is required to fill the information asked in Step-One of the application form, appearing on the computer screen. Candidate while registering, must see that he / she is giving his / her own email_id and mobile no., because all informations concerning registration will be sent on the same email_id and mobile no. Also the candidate will receive a SMS. The received email and SMS will contain a "**ACTIVATION CODE**" which is to be used by the candidate to activate his account. The candidate should click "**Activate Your Account**" Button and enter the email_id and received Activation code to activate his / her account. There after click the "**Submit**" button. After activating the account the candidate should click the "**Sign in**" button and enter the email Id and password to proceed further. The candidate must keep the password entered in Application Form confidential, otherwise BCECE Board will not be responsible for any complication. The email id given by the candidate will be his user name.

II. Step-two - (Personal Information) : After successful registration and activating the account, the candidate should again "**Sign in**" to his account and thereafter complete the required entries regarding personal information on the computer screen. Then click on "**Save & Continue**" button.

III. Step-Three - (Upload Photo and Signature) : After entering the personal information the candidate should upload his / her passport size photograph of high contrast (Photo must be snapped with placard containing candidate's name and snapping date), and full signature in Hindi and English (Not in capital letter) after duly scanning the same. After uploading photo and signature click on "**Save & Continue**" button.

IV. Step-Four - (Educational Information) : After uploading the scanned photo and signature the candidate should enter his / her educational information on the computer screen and click on "**Save & Continue**" button.

V. Step - Five (Preview your application) : After entering educational information the candidate must verify all the information given by him/her while verifying given information in step-2, step-3 and step-4. If any information is found wrong, then the candidate should click "**Back to Edit**" button and make required corrections. Thereafter the candidate should click "**Save & Continue**" button so that entered information should be updated.

If preview of application form is found to be correct, then the candidate give his / her Declaration and click the

"Confirm & Submit" button so that he / she should pay Examination Fee as per Step-Six.

VI. Step - Six (Payment of Counselling Fee) : After preview of the Application Form and submitting the same, the candidate should click "Proceed to Payment" button and complete the payment procedure according to instructions appeared on the computer screen regarding payment of Counselling Fee. Paid Counselling Fee will not to be refunded. There are following two modes for payment of Counselling Fee.

- a. **Online Payment :** If the candidate wants to pay Counselling Fee through Online mode e.g. Credit Card / Debit Card / Net banking, he / she should select online option from payment mode appearing on the computer screen and "Make the Payment" should be made through Credit Card / Debit Card / Net banking. The candidate has to pay processing charge additional to Counselling Fee for payment through online mode
- b. **Counselling Fee :** Counselling fee to be paid through above modes is Rs. 2200/- (Two Thousand Two Hundred) only for all categories i.e. (Unreserved / SC / ST / EBC / BC / DQ) candidates.

VII. Step - Seven (Download part- A & Part-B) : After payment of Counselling Fee upto scheduled date and time, the candidate must download Hard Copy (Part-A & and Part-B) of online submitted Application Form and keep the same safely in his possession because it contains all informations provided by the candidate and the PGMAC-ID made available by the Board for further use during counselling.

Note : a. Hard copy of PART-A & PART-B need not to be send Board's office, but instead this is to be made available at the time of counselling.

- b. After completing the above procedure and finally submitting the online application form, there is no provision for any change or modification in the same.
- c. The candidate must note that after submission of online application form, neither it can be withdrawn nor any request for refunding paid counselling fee will be entertained.
- d. Board will not be responsible for any interruption in Internet / Postal / Banking system. Therefore the candidates must not wait for last dates and complete all procedure before due date.
- e. **Those candidates who gives their wrong information like NEET(PG) Roll no., Name and Father's Name during submission of online Application form, their candidature will be summarily rejected.**
- f. Final Merit list for Medical course will be prepared after scrutinising the data provided by National Board of Examination/ Health Deptt., Govt. of Bihar.
- g. On the basis of merit and availability of seat, the 2nd Mop up Counselling programme will be published on the Board's Website on 16.05.2019 (8.00 P.M.).
- h. No other chance will be given to any candidate for submitting online application after due date for online submission of application.

4. Important dates for PGMAC-2019 :

- (i) Online Registration starting date : 13.05.2019
- (ii) Online Registration closing date : 15.05.2019(10.00 P.M.)
- (iii) Last date of payment through Net Banking / Debit Card / Credit Card with final submission of the online Application Form of Registered candidate : 15.05.2019 (11.59 P.M.)
- (iv) Publication of 2nd Mop Up Counselling Programme : 16.05.2019 (8.00 P.M.)
- (v) Date of 2nd Mop Up Counselling : 18.05.2019 (9.30 A.M.)
- (vi) Date of Admission : 18.05.2019

5. The candidates participating in the counselling are directed to come prepared to stay till next day of the scheduled date of counselling.

6. **Each candidate desirous of opting seats in any Private Medical Colleges, has to deposite a bank draft of Rs.200000/- (Two lakh) only in the favour of Controller of Examination, BCECE Board payable at Patna. If the candidate doesn't take admission on his allotted seat, the deposited amount will be forfeited and in case of taking admission, the amount will be transferred to the concerned Institution and will be adjusted against her / his fees.**

7. BCECE Board / Controller of examination reserves the right to amend / rectify any of the conditions of prospectus of PGMAC-2019 before the 2nd Mop up counselling of PGMAC-2019.

8. **The candidates who are admitted in any Govt. / Pvt. institution either under All India Quota seats or State Quota seats are not eligible for 2nd MOP UP Counselling.**

9. The candidates are directed to come for 2nd MOP UP counselling with all required original documents as per prospectus of PGMAC-2019, and also as mentioned in Advertisement No. BCECEB(PGMAC)-2019/01, 2019/02 Dated : 30.03.2019 , 2019/03 Dated : 03.04.2019 and 2019/08 , 2019/09 Dated 02.05.2019 otherwise they will not be allotted seat in this 2nd MOP UP Counselling.

10. The candidates participating in the 2nd MOP UP counselling on 18.05.2019 are advised to come prepared for taking admission same day.

Controller of Examination
