The list of qualified candidates of NEET-(PG-2020 which has been provided by National Board of Examination (NBE) / Health Department, Govt. of Bihar for admission to first year of the Post Graduate Govt. / Private Medical Colleges of Bihar State is already uploaded on Board's [website : bceceboard.bihar.gov.in](http://bceceboard.bihar.gov.in) .

2. **MOP UP Counselling will be conducted Off-line.**

3. In continuation to earlier published all concerned advertisement of PGMAC-2020, this is to inform all qualified, eligible and interested NEET-PG- 2020 candidates who have not duly filled the online application for PGMAC-2020 vide Adv.No.-BCECEB(PGMAC)-2020/01 & 2020/02 dated 17.04.2020, 2020/05 dated 11.07.2020 and 2020/16 & 2020/17 dated 06.08.2020 due to any reason and not admitted in any Govt./ Private institution of India and want to attend MOP UP counselling for MD / MS / PGD Course have to do fresh registration and submit online application form through visiting the link "**Online Application Portal of PGMAC-2020**" and by clicking "**Apply Online**" button from Board's website [bceceboard.bihar.gov.in](http://bceceboard.bihar.gov.in) for appearing in the Mop Up round of Post Graduate Medical Admission Counselling (PGMAC)-2020 **in order to select candidates for admission against vacant state quota seats in the FIRST YEAR** of the following Post Graduate Degree/ Diploma Courses ;

- (i) MD / MS / PG Diploma (PGD) Courses in Govt. Medical Colleges viz. Patna Medical College, Patna , Darbhanga Medical College, Darbhanga , Nalanda Medical College, Patna , A.N.M. Medical College, Gaya, J.L.N.M.C., Bhagalpur, S.K.M.C., Muzaffarpur , IGIMS Medical College, Patna and V.I.M.S., Pawapuri for the session 2020.
- (ii) MD / MS / PG Degree Courses in Private Medical Colleges viz. K.M.C., Katihar, M.G.M.M.C., Kishanganj, Narayan Medical College & Hospital, Sasaram for the session 2020.

The available vacant seat position after 2nd round of counselling of Medical will be uploaded on the Board's website [bceceboard.bihar.gov.in](http://bceceboard.bihar.gov.in) before the start of counselling.

Eligibility criteria for counselling, Fee and Fee payment procedure, instructions and other details are available in the Updated Revised Prospectus of PGMAC-2020 and the related Advertisement No. BCECEB(PGMAC)-2020/01 & 2020/02 Dated 17.04.2020 , 2020/05 Dated 11.07.2020 and 2020/16 & 2020/17 dated 06.08.2020 which can be downloaded from the Board's website [bceceboard.bihar.gov.in](http://bceceboard.bihar.gov.in) .

6. Those eligible and qualified NEET(PG)-2020 candidates who have already duly submitted Online application form in response to Advertisement no. BCECEB(PGMAC)-2020/01 & 2020/02 Dated 17.04.2020 , 2020/05 Dated 11.07.2020 and 2020/16 & 2020/17 dated 06.08.2020 respectively and whose name and PGMAC-ID is already included in the merit list published on Board's website and **is not admitted in any Medical College in India** have to give their willingness for attending Mop up counselling as per programme given below by clicking the link "**Online Application Portal of PGMAC-2020**" and "**Apply Online**" button and login to account by entering registered email ID and Password by clicking "**Sign In**" button. After Successful login, Click on "**Willingness for Medical Mop-up Counselling**" button and fill the required informations as asked on the screen. Click on "**Save**" button. Candidates are also advised to download or take a print out of filled application for further use.

7. Those candidates, who have successfully done the registration as per earlier Advertisement but due to any reason could not fill their online application form completely with payment of counselling fee can also login to their account and complete their rest steps through visiting the link "Online Application Portal of PGMAC-2020" and by clicking "Apply Online" button from Board's website : [bceceboard.bihar.gov.in](http://bceceboard.bihar.gov.in) .

8. Qualified, eligible & interested NEET(PG)-2020 candidates who are eligible for granting weightage marks as per MCI regulation for work experience for working in remote / difficult area notified by Health Deptt., Govt. of Bihar vide Notification no. सं.सं.- 2/कोट-59/13-1037(2)/Health dt. 27.08.2013 and are in service of Bihar Government / Public Authority and have not filled online application for PGMAC-2020 earlier, are also being given a chance to fill the Online Application form for PGMAC-2020 as per procedure given in para-4 and will have to upload the

required experience certificate (See Annexure-3A of PGMAC-2020 Updated Revised Prospectus). as per the programme given below.

If any candidate fails to upload the remote area working experience certificate, he/she will not be considered for incentive marks as per MCI Rules for remote/difficult area. For more details kindly refer to Adv.No.BCECEB(PGMAC)-2020/16 & 2020/17 Dated 06.08.2020 uploaded on Board's website.

9. Candidate will have to produce his/her original certificate at the entrance gate of Counselling Hall and during the time of document verification / seat allotment process for Mop-Up counselling, otherwise he / she will not be considered for counselling. In case of opting seat for admission their original documents will be retained.

- (vi) Date of Uploading Seat Matrix ..... : **26.08.2020**
- (vii) Date of Mop Up Counselling ..... : **27.08.2020 to 28.08.2020**

11. The candidates participating in the counselling are directed to come prepared to stay till next day of the scheduled date of counselling.

**12. The candidates desirous of opting seats in any Private Medical Colleges, he has to deposit a bank draft of Rs. 200000/- (Two lakh) only in the name of Controller of Examination, BCECE Board payable at Patna. If the candidate doesn't take admission on his allotted seat, the deposited amount will be forfeited and in case of taking admission, he/she has to deposit the rest amount of required fee to the concerned institution latest by 29.08.2020. The candidates have to show the Bank Draft at the time of signing his attendance and have to deposit / submit the bank draft as well as original documents at the announcement table of counselling hall, other wise he / she will not be allowed to participate in the MOP UP Counselling.**
