Important Notice for Special Stray Vacancy Round Online Counselling

In continuation to the Adv.No. BCECEB(PGMAC)-2024/24 & 2024/25 dated 04.03.2025 and 2024/26 dated 05.03.2025, Rank Card of all candidates who have duly submitted Fresh Online Application Form as well as who have given their Willingness for participating in Special Stray Vacancy Round Counselling, their Rank Card has been uploaded on Board's website : bceceboard.bihar.gov.in. **Candidates are advised to download their Rank Card of PGMAC-2024 by clicking the link "Rank Card of Special Stray Vacancy Round Counselling of PGMAC-2024"** by submitting their PGMAC ID and Date of Birth.

After downloading the rank card, candidates will have to do choice filling for online counselling. For online choice filling, all eligible candidates are required to click on link "**Online Counselling Portal of PGMAC-2024**". After clicking the link candidates are advised to do the registration for online counselling by submitting the data as asked on the computer screen.

2. The updated Seat Matrix for PGMAC-2024 Counselling has been uploaded on Board's Website. The candidate must see it before filling up of their Choices for Online Counselling.
3. In the light of Adv.No.BCECEB(PGMAC)-2024/24 & 2024/25 dated 04.03.2025, candidates who have duly submitted Fresh Online Application Form or given Willingness for Special Stray Vacancy Round Counselling of PGMAC-2024 are eligible for Special Stray Vacancy Round Counselling (if found eligible).

All such candidates will have to login to their account of online counselling portal by clicking the link "Online Counselling Portal of PGMAC-2024" available on Board's website and will fill Fresh Choices for Special Stray Vacancy Round Counselling as their previous filled choices (if any) will become Null & Void. It is mandatory to do Fresh Choice Filling.

4. Candidates participating in Special Stray Vacancy Round Counselling will have to furnish an undertaking with respect to allotment of seats at the time of Choice Filling on online Counselling portal of PGMAC-2024 as under;

"I agree to participate in the Special Stray Vacancy Round Counselling of PGMAC-2024. I affirm that I fulfill the eligibility criteria as mentioned in the Notice Adv. No. BCECEB(PGMAC)-2024/24 dated 04.03.2025 and 2024/27 dated 12.03.2025 for Special Stray Vacancy Round Counselling of PGMAC-2024.

I understand that these seats are precious in nature. Hence, if I am allotted a seat during the Special Stray Vacancy Round Counselling, I will join the allotted seat. If, due to any reason I do not join the allotted seat my refundable security deposit will be forfeited and any action including legal may be taken by the competent Authority."

5. For Choice filling, candidates are required to do the registration for password creation on counselling portal. Then using their User ID & Password login in their account, candidates have to fill in choices of Course and Institution / Colleges in order of preference. Once choices are filled in, it can be modified before locking it. For this, candidates have to click on "Unlock Choices" button after authentication / verification of obtained OTP on their Registered Mobile no. and email, and can modify their choices till last date of choice locking. During the choice locking period it is necessary to lock the choices to get a print of their submitted choices. If candidate does not lock the choice submitted, their choice will be automatically locked on notified date at notified time, however candidate will be allowed to take a print of their choices after locking, but he / she will not be permitted to modify choices after locking.

Note : Registration for Choice filling, Choice locking & unlocking process will be done through OTP authentication only which will be sent on Registered Mobile & email of the candidates which can not be changed in any circumstances.

6. The list of finally filled in choices will be sent to candidates on their Registered email ID before seat allotment result.
7. The seat allotment will be done on merit-cum-choice basis. **Provisional seat allotment order will be made available on Board's website on 17.03.2025** and accordingly candidate may send objection on 17.03.2025 to email_id: objection.bceceboard@gmail.com through his / her registered email_id. After reviewing the received objections, Final Seat Allotment Result **will be made available on Board's website on 18.03.2025**.
8. All eligible candidates are advised to login their account in schedule period of date & time and view the provisionally allotted seat result and download their provisional allotment order.

In case candidate is allotted seat during Special Stray Vacancy Round seat allotment, he/she has to report physically at reporting centre for Document Verification. After document verification if he is found eligible will take admission as per programme given below and as per rule mentioned in PGMAC-2024 Prospectus.

9. If any candidates who have been allotted a seat in Special Stray Vacancy Round Counselling but due to any reason could not report to reporting centre for document verification within prescribed date or appeared for document verification but do not take admission on their Special Stray Vacancy Round allotted seat or found not eligible during document verification due to any discrepancy, then their paid Security Deposit amount will be **forfeited** and the allotted seat will be cancelled as well as will not be eligible for further Counselling (if conducted). In this regard action including legal may be taken by the competent Authority.

10. In case of any discrepancies, the Rules and Regulations of MCC (PG Counselling) / PGMAC-2024 Prospectus will be followed.
11. Eligibility criteria and instructions and other details are available in the Prospectus of PGMAC-2024 which can be downloaded from the Board's website bceceboard.bihar.gov.in.
