In continuation to the Adv. No.- BCECEB(PGPAC)-2023/01, 2023/02 Dated 13.11.2023, it is to inform to all concerned related to PGPAC-2023 that the candidates who are qualified and eligible on the basis of the prospectus of Post Graduate Pharmacy Admission Counselling (PGPAC)-2023 and who have duly applied in response to Adv. No.- BCECEB(PGPAC)-2023/01, 2023/02 Dated 13.11.2023 are included in the counselling programme for allotment of M. Pharm (Pharmaceutics/ Pharmaceutical Chemistry Course) in G.P.I., Patna.

- 2. Each eligible candidate who is included in merit list has to appear for counselling on the scheduled date alongwith the print copy of already 'online' filled part-A and Part-B application form, the original certificates / documents as per the prospectus of PGPAC-2023. After verification of certificates / documents/ identity, the course / institution will be allotted merit / rank wise to eligible candidates as per prospectus of PGPAC-2023.
- 3. The PGPAC ID of reserve category candidates who competed in Unreserved category have been included in Unreserved (UR) as well as in their respective reserveed categories. The seat of reserved category will remain open during the counselling of UR category and Reserved Category candidates present in UR merit list will have option to opt UR seat as well as there category seat. Therefore, Reserve Category (RC) candidates who are included in Unreserved Category must come for counselling on the date fixed at their Unreserved Category merit serial for option of course / institution available in Unreserved category as well as reserve category, otherwise the reserved category seat available at their merit Serial may be opted and alloted to the candidate of lower merit for which be they themself could be responsible. This is to be noted that as per reservation policy, Seats of UR category, which will be blocked due to such jump over, will be opened only on the day of the respective categories counselling.
- 4. The counselling / Interview will be held at the office of Bihar Combined Entrance Competitive Examination Board, IAS Association Building, Near Patna Airport, Patna-14.

 - (ix) Six copies of passport size photograph which were uploaded during filling of Online Application Form.

- 7. Inclusion of any PGPAC ID in the above Counselling programme does not guarantee admission. It totally depends upon fulfilment of eligibility criteria.
- 8. Rank Card of PGPAC-2023 has been uploaded on Board's website beeceboard.bihar.gov.in which can be obtained by clicking the Link "Download Rank Card of PGPAC-2023" using his / her PGPAC ID and Date of Birth.
- 9. If a candidate called for Counselling / Interview is found ineligible as per the requirements of the prospectus of PGPAC-2023 and / or the latest order/ orders passed by the Hon'ble High Court/ Supreme Court or Department of Health, Govt. of Bihar in matters related to PGPAC-2023, his / her candidature is liable to be rejected.
- 10. Each eligible candidate will be allowed to exercise his/ her option for Course/ Institution from amongst those available at his/ her merit serial after his/ her original Certificates/ Documents and identity are verified.
- 11. A candidate who absents or fails to appear on the scheduled date & time of his/ her Counselling/Interview may appear for Counselling any time during the period of Counselling of his/her respective category, but in that case he/ she will have the option of Course/ Institution available at the time of his/ her actual reporting.
- 12. Each candidate should note that once the Course/Institution is opted at the time of his/ her Counselling in his/ her concerned category for which his/ her choice is allowed and the same is allotted to him/ her, no subsequent request for change of course and/ or Institution in the same category shall be entertained.
- 13. Admission fee and other related charges shall have to be deposited at the time of admission in the concerned college.
- 14. In case of dispute, decision of the Controller of Examination, BCECEB shall be final.
- 15. The Department of Health, Govt. of Bihar and the Bihar Combined Entrance Competitive Examination Board reserve the right to amend the rules relating to PGPAC-2023.
