IMPORTANT NOTICE for B. Arch. Course

In continuation to Adv. No.- BCECEB(UGEAC)-2026/05 & 2026/06 Dated 29.06.2026, it is to inform to all concerned related to UGEAC-2026 (B. Arch.) that the candidates who are qualified and eligible on the basis of the prospectus of Under Graduate Engineering Admission Counselling (UGEAC)-2026 (B. Arch.) and who have duly submitted the application form in response to Adv. No.- BCECEB(UGEAC)-2026/05 & 2026/06 Dated 29.06.2026 are included in the counselling programme for allotment of 5-Year full-time Bachelor of Architecture Course in Gaya College of Engg., Gaya.

2. **Rank Card of UGEAC-2026 (B. Arch.) has been uploaded on Board's website bceceboard.bihar.gov.in which can be obtained by clicking the Link "Download Rank Card of UGEAC-2026 (B.Arch.)" using his / her UGAAC ID and Date of Birth.**

3. **The Counselling will be Offline.**

4. Each eligible candidate who is included in merit list has to appear for counselling on the scheduled date alongwith the print copy of downloaded Confirmation Page of online filled Application Form, the original certificates / documents as per the prospectus of UGEAC-2026. After verification of identity /certificates / documents, the Institution / Course will be allotted on merit-cum-choice basis to eligible candidates as per prospectus of UGEAC-2026.

5. The UGAAC ID of reserve category candidates who competed in Unreserved (UR) category have been included in UR as well as their respective reserve categories. **Therefore, reserved category candidates who are included in UR Category must come for counselling on the date and time fixed for the same at their UR merit serial for option of course / institution available in UR category failing which the seat available at that UR merit will be allotted to candidates of lower merit for which candidate will be himself responsible. This is to be noted that as per reservation policy seats of UR category which will be blocked due to such jump over, will be opened only on the day of the respective category counselling.**

6. The counselling / Interview will be held at the office of Bihar Combined Entrance Competitive Examination Board, IAS Association Building, Near Patna Airport, Patna-14.

It is to be noted that firstly the available seats shall be filled up by JEE (Main)-2026 (Paper-II) qualified candidates, and if seat remains vacant then the vacant seats will be filled by candidate who got Valid Score in NATA-2026 Examination conducted by the Council of Architecture, on Merit-cum-choice basis.

9. All the certificates included in the list given below, **if applicable**, must be submitted in original by the candidate at the time of his/ her Counselling on the scheduled date :

- (i) JEE (Main)-2026 Paper-II Score Card / NATA Score Card (if applicable)
- (ii) Rank Card of UGEAC-2026 (B. Arch.)
- (iii) Passing Certificate / Marks Sheet / Admit Card of Matric / Equivalent Examination.
- (iv) Passing Certificate / Marks Sheet / Admit Card of Intermediate Sc. / Equivalent Examination.
- (v) Residence Certificate duly issued by concerned C.O. / R.O.
- (vi) Caste Certificate duly issued by Concerned C.O. / R.O. of Permanent Residence.
- (vii) Six copies of passport size photograph which were uploaded during filling of Online Application Form.
- (viii) Copy of Aadhar Card.
- (xv) Print copy of downloaded Confirmation Page of online filled Application Form UGEAC-2026 (B. Arch.).
- (xvi) The Verification Slip in 2 copies and Biometric Form one copy as downloaded.

10. Inclusion of any UGAAC ID in the above Counselling/ Interview programme does not guarantee admission. Candidates in excess of the available seats are being called for Counselling / Interview in order to ensure filling up vacancies which may arise due to absentees.

11. If a candidate called for Counselling / Interview is found ineligible as per the requirements of the prospectus of UGEAC-2026 and / or the latest order/ orders passed by the Hon'ble High Court/ Supreme Court or Department of Science & Technology in matters related to UGEAC-2026, his / her candidature is liable to be rejected.

12. Each eligible candidate will be allowed to exercise his/ her option for Course/ Institution from amongst those available at his/ her merit serial after his/ her original Certificates/ Documents and identity are verified.

13. A candidate who absents or fails to appear on the scheduled date & time of his/ her Counselling/Interview may appear for Counselling any time during the period of Counselling of his/her respective category, but in that case he/ she will have the option of Course/ Institution available at the time of his/ her actual reporting.

14. Each candidate should note that once the Course/ Institution is opted at the time of his/ her Counselling in his/ her concerned category for which his/ her choice is allowed and the same is allotted to him/ her, no subsequent request for change of course and/ or Institution in the same category shall be entertained.

15. Admission fee and other related charges shall have to be deposited at the time of admission in the concerned college.

16. In case of dispute, decision of the Controller of Examination, BCECEB shall be final.

17. The Department of Science, Technology & Technical Education, Govt. of Bihar and the Bihar Combined Entrance Competitive Examination Board reserve the right to amend the rules relating to UGEAC-2026.
