### **Important Notice for MOP-UP Counselling**

NEET-2019 qualified candidates, candidates included in merit list of UGMAC-2019 and all concerned institutions are hereby informed that on the vacant seats after admission on the basis of UGMAC-2019 online 2nd Counselling, **offline MOP-UP Counselling will start from 30.08.2019. MOP-UP Counselling will be offline.** For admission in Govt./ Pvt. Medical/ Dental/ B.V.Sc. colleges of Bihar state, only such NEET(UG)-2019 candidates are eligible who fulfill the eligibility criteria as per the prospectus and are not admitted in any Govt./Pvt. Medical/Dental Colleges of India. The detailed programme / process have been uploaded on the Board's website: **bceceboard.bihar.gov.in vide adv. No. BCECEB(UGMAC)-2019/25 Dated 28.08.2019.**

2(a). All candidates who want to participate and to take the admission on the vacant seats available after admission on the basis of 2nd round online counselling at their merit in Govt. Medical / Dental / B.V.Sc. have to take admission on the same day during MOP-UP counselling process by submitting the required original documents and requisite fee amount.

(b). All candidates who want to take admission in Pvt. Medical / Dental Colleges are directed to submit a Demand Draft of Rs.12,00,000/- (twelve lac) for Private Medical Colleges and Rs.3,00,000/- (three lac) for Pvt. Dental Colleges in favour of Controller of Examination, BCECE Board payable at Patna failing which they would not be given chance for Document Verification and admission. If the candidate is admitted he has to deposit cheque of rest amount of fee of that institution after then within two days of admission, he has to deposit the Bank Draft of the amount of the cheque and cheque will be returned back to the candidate by the concerned institution.

(c). Fee structure for Govt. Medical / Dental / B.V.Sc. colleges and Pvt. Medical / Dental Colleges are uploaded on the Board's website.

3. The concerned candidates are requested to go through it and attend the MOP-UP Counselling accordingly.
