In continuation to Advertisement no BCECEB(UGMAC)-2019/28 & BCECEB(UGMAC)-2019/29 Dated 03.09.2019 It is to inform to all candidates/Concerned institutions that the fresh Registration and Filling up of Online Application Form with Payment for 2nd MOP-UP Counselling for Dental Colleges based on UGMAC-2019 has been extended for Registration upto 09.09.2019 (10:00 P.M) and for completion of rest Steps upto 09.09.2019 (11:59 P.M). **The NEET(UG)-2019 Qualifying Percentile for BDS Courses as per Dental Council of India Notification No. DE-BDS(Gen)Admission-2019/4436 Dated: 06.09.2019 and Family of Health and Welfare Department Govt. of India Letter No. F.No.V.12025/143/2019 Dated 06.09.2019 is given below;**

2(a). All candidates who want to participate and to take the admission on the vacant seats available after admission on the basis of MOP-UP round counselling at their merit in Dental Colleges have to take admission on the same day during 2nd MOP-UP counselling process by submitting the required original documents and requisite fee amount.

(b). All candidates who want to take admission in Pvt. Dental Colleges are directed to submit a **Demand Draft of Rs.50,000/- (fifty thousand) in favour of Controller of Examination, BCECE Board payable at Patna** failing which they would not be given chance for Document Verification and admission. If the candidate is admitted he has to deposit cheque of rest amount of fee of that institution after then within two days of admission, he has to deposit the Bank Draft of the amount of the cheque and cheque will be returned back to the candidate by the concerned institution.
