Important Notice for 2nd MOP-UP Counselling for BDS Course

This is to inform all eligible candidates and all concerned that on the vacant seats after admission on the basis of Mop-up Counselling of UGMAC-2022, offline 2nd MOP-UP counselling for BDS Course will be held on 26.12.2022 at I.A.S. Bhawan, Near Patna Airport, Patna-800014 for admission to BDS courses in Private Dental Colleges of Bihar.

2nd MOP-UP ROUND COUNSELLING FOR BDS COURSE WILL BE OFFLINE.

2. UGMAC ID of all valid candidates, who have duly submitted the online application form for UGMAC-2022 (BDS Course) 2nd Mop-up Counselling in the light of Adv. No. BCECEB(UGMAC)-2022/13 & 2022/14 dt. 20.12.2022 and found eligible as per the NEET Cutoff Marks or other eligibility criteria and are not admitted in any Medical and Dental Colleges of India either through UGMAC-2022 1st, 2nd Round & Mop-up Round of Counselling or All India Quota Counselling or according to list of candidates joint upto Mop-up round of counselling conducted by other states, uploaded on MCC Website are included Merit-row wise in the 2nd MOP-UP (for BDS Course) counselling programme mentioned below.

3. For admission in Pvt. Dental colleges of Bihar state, only such NEET(UG)-2022 candidates are eligible who fulfill the eligibility criteria as per the prospectus and are not admitted in any Govt. / Pvt. Medical / Dental Colleges of India. **Candidates must have to bring their all original documents alongwith Rank Card for 2nd MOP-UP counselling at the time of counselling as mentioned in the prospectus of UGMAC-2022, otherwise they will not be considered eligible for attending 2nd MOP-UP counselling.**

4(a). Fee structure for Pvt. Dental Colleges are uploaded on the Board's website and is also available on respective colleges website.

(b) **Each candidate desirous of opting seats in any Private Dental Colleges, has to come with all required original documents and a Bank Draft of Rs.50,000/- (Fifty thousand) only in favour of Controller of Examination, BCECE Board payable at Patna. If the candidate is allotted a seat, he will be treated as admitted and he has to complete all other formalities by depositing the difference amount of fees within prescribed period. The deposited part fee of Rs.50,000/- (for Dental) will be transferred to the concerned Institution.** The candidates have to show the bank draft at the time of giving his/ her attendance at attendance counter and have to submit the required bank draft and original certificates at the entrance gate of counselling hall otherwise he / she will not be allowed to participate in counselling.

(c) Last date submission of required Rest (Pvt.) amount of fee and admission is 27.12.2022. Any request for extension of submission of fee or admission date or leaving the allotted seat will not be entertained in any case.

5. All the registered candidates who are eligible as per criteria, have been called for 2nd MOP-UP Counselling for BDS Course as per counselling programme given below. The seat matrix is uploaded on the Board's website. During the counselling process, the vacancies will be updated.

6. The 2nd MOP-UP Counselling programme for BDS Course with UGMAC ID merit wise is being given as under ;

7. During any stage of Counselling / Document verification, if any candidate included in above merit list is found admitted in any Medical / Dental College of India he will not be eligible for seat allotment in this 2nd MOP-up counselling.

8. **All the certificates included in the list given below, if applicable, must have to submit in original at the time of his/ her Counselling / Allotment on the scheduled date otherwise they shall not be eligible for counselling / admission ;**

- i. Original Admit Card of NEET(UG)-2022.
- ii. Downloaded print of Online filled Application Form (Part-A & Part-B) UGMAC-2022 (2nd Mop-up Counselling).
- iii. The Check Slip (जाँच-पर्ची) 2 (two) copy as downloaded alongwith Biometric Identification Report Form 1 (one) copy.

- iv. Rank Card of UGMAC-2022 for 2nd Mop-up Counselling of BDS Course .
 - v. Passing Certificate / Marks Sheet / Admit Card of Matric / equivalent Examination.
 - vi. Passing Certificate / Marks Sheet / Admit Card of Intermediate Sc / equivalent Examination.
 - vii. Certificate for Residence of Bihar duly issued by Concerned C.O. / Revenue Officer of permanent residence.
 - viii. Caste Certificate duly issued by Concerned C.O. / Revenue Officer.
 - ix. All the Certificates in original as per the requirements of the Prospectus of UGMAC-2022 (if applicable).
 - x. Six copies of the passport size Photograph which was pasted on the Admit Card NEET(UG)-2022.
9. Inclusion of any UGMAC-ID in the above Counselling programme does not guarantee admission. It totally depends upon fulfilment of eligibility criteria.
 10. If the counselling does not complete on scheduled date due to any reason, the concerned candidates have to stay for the next day in order to complete it.
 11. If a candidate called for 2nd MOP-UP Counselling / Allotment for BDS Course is found ineligible as per the requirements of the prospectus of UGMAC-2022 and / or the latest order/ orders passed by the Hon'ble High Court/ Supreme Court Apex Bodies or Department of Health in matters related to UGMAC-2022, his / her candidature is liable to be rejected.
 12. Each eligible candidate will be allowed to exercise his/ her option for Course/ Institution from amongst those institutions & seats available at his/ her merit serial after his/ her original Certificates/ Documents and identity are verified.
 13. A candidate who absents or fails to appear on the scheduled date & time of his/ her Counselling/Allotment may appear for Counselling any time during the period of Counselling but in that case he/ she will have the option of Course/ Institution available at the time of his/ her actual reporting at allotment table.
 14. Each candidate should note that once the Course/ Institution is opted at the time of his/ her Counselling in his/ her concerned category for which his/ her choice is allowed and the same is allotted to him/ her, no subsequent request for change of course and/ or Institution or leaving the allotted seat shall be entertained.
 15. The updated vacancy position of seat for 2nd MOP-UP Counselling for BDS Course can be seen on Board's Website. The available vacancies may change at the time of starting Counselling on 26.12.2022 and will be updated as mentioned above.
 16. In case of dispute, decision of the Controller of Examination, BCECEB shall be final.
 17. The Govt. of Bihar and the Bihar Combined Entrance Competitive Examination Board reserve the right to amend the rules relating to UGMAC-2022.
 18. Other terms and condition as given earlier vide Advertisement No. BCECEB (UGMAC)-2022/13 dt. 20.12.2022 will remain the same.
