**Notice related to Offline Counselling for B.V.Sc. & A.H. Course**

In continuation to Adv. No.- BCECEB(UGMAC)-2023/18 Dated 11.10.2023, it is to inform all eligible candidates and all concerned that on the vacant seats after admission on the basis of Round-3 Counselling of UGMAC-2023, offline Counselling for B.V.Sc. & A.H. Course will be held on 30.10.2023 at I.A.S. Bhawan, Near Patna Airport, Patna-800014 For admission to UG Degree (B.V.Sc. & A.H.) Course of the Government Veterinary Colleges are mentioned hereunder ;

- (i) College of Veterinary & Animal Sciences, Kishanganj.
- (ii) On vacant seats of Bihar Veterinary College, Patna after admission on the basis of UGMAC-2023 Round-3 Counselling.
2. COUNSELLING FOR B.V.Sc. & A.H. COURSE WILL BE OFFLINE.
3. UGMAC ID of all valid candidates, who have duly submitted the fresh online application form for UGMAC-2023 (B.V.Sc. & A.H. Course) offline Counselling in the light of Adv. No. BCECEB(UGMAC)-2023/18 Dated 11.10.2023 and found eligible as per the NEET Cutoff Marks or other eligibility criteria and are not admitted in any Medical and Dental Colleges of India either through UGMAC-2023 Round-1, Round-2, Round-3, Stray Vacancy Round of Counselling or All India Quota Counselling or according to list of candidates joined upto above round of counselling conducted by other states, uploaded on MCC Website are included Merit-row wise in the (for B.V.Sc. & A.H. Course) counselling programme mentioned below.
4. For admission in Veterinary Colleges of Bihar state, only such NEET(UG)-2023 candidates are eligible who fulfill the eligibility criteria as per the Updated Prospectus and are not admitted in any Govt. / Pvt. Medical / Dental Colleges of India. **Candidates must have to bring their all original documents alongwith Rank Card for Counselling at the time of counselling as mentioned in the Updated Prospectus of UGMAC-2023, otherwise they will not be considered eligible for attending counselling.**
- 5(a). Fee structure for Veterinary Colleges are uploaded on the Board's website and is also available on respective colleges website.
- (b) After seat allotment, student have to take admission on the same day during Counselling process by depositing the requisite fee amount.
6. The UGMAC ID of reserve category candidates who competed in Unreserved category have been included in Unreserved (UR) as well as in their respective reserved categories. The seat of reserved category will remain open during the counselling of UR category and Reserved Category candidates present in UR merit list will have option to opt UR seat as well as there category seat. **Therefore, Reserve Category (RC) candidates who are included in Unreserved Category must come for counselling on the date fixed at their Unreserved Category merit serial for option of course / institution available in Unreserved category as well as reserve category**, otherwise the reserved category seat available at their merit Serial may be opted and allotted to the candidate of lower merit for which be they themselves could be responsible. This is to be noted that as per reservation policy, Seats of UR category, which will be blocked due to such jump over, will be opened only on the day of the respective categories counselling.
7. All the registered candidates who are eligible as per criteria, have been called for Counselling for B.V.Sc. & A.H. Course as per counselling programme given below. The seat matrix is uploaded on the Board's website. During the counselling process, the vacancies will be updated.

9. All the certificates included in the list given below, if applicable, must have to submit in original at the time of his/ her Counselling / Allotment on the scheduled date otherwise they shall not be eligible for counselling / admission;

- Original Admit Card of NEET(UG)-2023.
- Downloaded print of Online filled Application Form (Part-A & Part-B) UGMAC-2023 (Counselling).
- The Check Slip (जाँच-पत्ती) 2 (two) copy as downloaded alongwith Biometric Identification Report Form 1 (one) copy.
- Rank Card of UGMAC-2023 for Counselling of B.V.Sc. & A.H. Course .
- Passing Certificate / Marks Sheet / Admit Card of Matric / equivalent Examination.
- Passing Certificate / Marks Sheet / Admit Card of Intermediate Sc / equivalent Examination.
- Certificate for Residence of Bihar duly issued by Concerned C.O. / Revenue Officer of permanent residence.
- Caste Certificate duly issued by Concerned C.O. / Revenue Officer.
- All the Certificates in original as per the requirements of the Prospectus of UGMAC-2023 (if applicable).
- Six copies of the passport size Photograph which was pasted on the Admit Card NEET(UG)-2023.

10. Inclusion of any UGMAC-ID in the above Counselling programme does not guarantee admission. It totally depends upon fulfilment of eligibility criteria.

11. If the counselling does not complete on scheduled date due to any reason, the concerned candidates have to stay for the next day in order to complete it.

12. If a candidate called for Counselling / Allotment for B.V.Sc. & A.H. Course is found ineligible as per the requirements of the prospectus of UGMAC-2023 and / or the latest order/ orders passed by the Hon'ble High Court/ Supreme Court Appex Bodies or Department of Health in matters related to UGMAC-2023, his / her candidature is liable to be rejected.

13. Each eligible candidate will be allowed to exercise his/ her option for Course/ Institution from amongst those institution & seats available at his/ her merit serial after his/ her original Certificates/ Documents and identity are verified.

14. A candidate who absents or fails to appear on the scheduled date & time of his/ her Counselling/Allotment may appear for Counselling any time during the period of Counselling but in that case he/ she will have the option of Course/ Institution available at the time of his/ her actual reporting at allotment table.
15. Each candidate should note that once the Course/ Institution is opted at the time of his/ her Counselling in his/ her concerned category for which his/ her choice is allowed and the same is allotted to him/ her, no subsequent request for change of course and/ or Institution or leaving the allotted seat shall be entertained.
16. The updated vacancy position of seat for Counselling for B.V.Sc. & A.H. Course can be seen on Board's Website. The available vacancies may change at the time of starting Counselling on 30.10.2023 and will be updated as mentioned above.
17. In case of dispute, decision of the Controller of Examination, BCECEB shall be final.
18. The Govt. of Bihar and the Bihar Combined Entrance Competitive Examination Board reserve the right to amend the rules relating to UGMAC-2023.
19. Other terms and condition as given earlier vide Advertisement No. BCECEB (UGMAC)-2023/18 dt. 11.10.2023 will remain the same.
20. Any typographical error inspite of all precautions taken and detected any time shall be corrected whenever detected and merely publication of UGMAC-ID will not confer any right for admission.
