## Important Notice for UGMAC-2024 Special Stray Vacancy Round Online Counselling

In continuation to the advertisement No.BCECEB(UGMAC)-2024/21 dated: 11.11.2024, all UGMAC-2024 candidates, who have duly submitted the Online Application Form vide Adv. No.- BCECEB(UGMAC)-2024/01 & 2024/02 dated: 24.08.2024, 2024/15 dated: 14.10.2024 and 2024/19 dated: 04.11.2024, and is in the merit list of UGMAC-2024 from R-1 to Stray Vacancy Round is hereby informed that as per the Medical Counselling Committee schedule notification dt. 16.11.2024, Special Stray Vacancy Round Counselling will be held from 25th November, 2024 to 5th December, 2024.

- 2. Special Stray Vacancy Round Counselling will be conducted Online.
- 3. National Medical Commission has given the letter of permission (LOP) for Lord Buddha Koshi Medical College, Saharsa for additional 50 seats for the academic year 2024-2025 vide lletter no. N-22011(04)/2024 Assessment Cell / MARB (8276250) dt. 05.11.2024. These seats are being added to the seat matrix in the last stage of Counselling i.e. in this Special Stray Vacancy Round. As the situation is extraordinary and since new seats are being added, hence in the welfare of the candidates it has been decided to allow for reallotment in this Special Stray Vacancy Round Counselling.
- 4. Based on the MCC guidelines, the BCECE Board has decided to conduct Special Stray Vacancy Round online Counselling with the following eligibility criteria;

### A). ELIGIBLE CANDIDATES:

- Those candidates of UGMAC-2024 who do not hold any seat and are present in merit list of UGMAC-2024 are eligible to register / for giving Willingness for Special Stray Vacancy Round.
- ii. All those candidates who have joined before and are admitted in R-1 / R-2 / R-3 / Stray Vacancy Round on the basis of UGMAC-2024 of Bihar State are eligible for reallotment but they have to Submit Willingness for this Special Stray Vacancy Round to raise **virtual vacancies**.

## B). NOT ELIGIBLE CANDIDATES:

- i. Those candidates who are admitted through AIQ and continuing on the basis of R-1 / R-2 / R-3 / Stray Vacancy Round are not eligible for Special Stray Vacancy Round.
- Those candidates who have been allotted seat in AIQ Stray Vacancy Round and Special Stray Vacancy Round will not be eligible for this Special Stray Vacancy Round of UGMAC-2024.
- i. All UGMAC-2024 registered candidates irrespective of their category are required to pay a Refundable Security Deposit of Rs. 50,000/- for participation and exercising choices for Govt. Medical / Dental / Veterinary seats in this Special Stray Vacancy Round.
  - ii. Those candidates of UGMAC-2024 who are Willing for admission in Private Medical Colleges will have to pay the Refundable Security Deposit of Rs. 3,00,000/- to exercise choices for Private Medical Colleges and in case of Private Dental Colleges will have to pay Rs.1,50,000/-.
- 6. Candidates are advised that those candidates who give their willingness and who want to take admission on alloted seat on the basis of this round they must fill their choices very carefully. If the candidates do not take admission on their allotted MBBS / BDS seat, they will have to forfeit the Security Deposit and Tuition fee already paid and will be debarred from participation in next academic year of UGMAC-2025 Counselling.
- 7. Process for Submission of Willingness: For submission of Willingness for participating in Special Stray Vacancy Round Counselling, candidate will click the Link "Online Application Portal of UGMAC-2024" available on Board's Website by login to their account through entering their Registered email ID & Password. After successfull login the candidate will have the facility to edit their pre-filled data. The candidate will click on Save & Continue button of each pages and finally check the filledup data on the preview page. After that candidate will click "Make Payment & Submit Willingness" button and do the payment of requisite Security Deposit Amount as per para 11(a). After successfull payment, Willingness will get submitted automatically and in this regard an email will be sent to candidate's registered email ID.
- **Note:** (i) All such candidates who will give willingness for participating for Special Stray Vacancy Round Counselling will have to re-download their Hard Copy (Part-A & Part-B).
  - (ii) All such candidates will have to fill fresh choices for Special Stray Vacancy Round Counselling as their previous filled choices will become "Null & Void". Detailed information regarding choice filling / seat allotment result / admission process will be published later on through concerned advertisement.

- 8. In case of any discrepancies, the Rules and Regulations of MCC (MDS Counselling) / UGMAC-2024 Prospectus will be followed.
- 9. **Seat Matrix of vacancies after completion of Stray Vacancy Round Counselling will be available on Board's website from 25.11.2024.** If any further vacancies arises, the Seat matrix of updated vacancies shall be uploaded on the Board's website before start of Special Stray Vacancy Round Counselling.
- 10. As re-allotment will be done, hence candidates are advised to fill their choices keeping in mind that virtual vacancy may arise.
- 11. **(A) Payment of Security Deposit :** The details of payment of security deposit for Govt. / Pvt. Medical Colleges/Dental Colleges/ Veterinary will be as follows;

As per above table, the candidate has to pay the refundable security deposit through online mode only e.g. by Credit card/Debit Card/ Net Banking / UPI at the time of submission of Willingness. The candidate has also to pay processing charge in addition to Security Deposit for payment through online mode.

**Note:** (i) If the amount paid as Examination / Counselling fee is debited from your account but the fee transaction fails, then in such a case you must re-pay the desired full fee and ensure the payment. If your required Examination / Counselling fee do not reflect in Board's account within the due date, your application form will remain incomplete and you will not be eligible for Examination / Counselling.

Your failed deducted amount from bank will be refunded to your account.

- (B) Downloading of Part- A & Part-B: After payment of Security Deposit upto scheduled date and time, the candidate must download Hard Copy (Part-A & Part-B) of online submitted Application Form and keep the same safely in his possession because it contains all informations provided by the candidate and the UGMAC-ID made available by the Board for further use during counselling.
- **Note:** a. Hard copy of PART-A & PART-B need not to be send to Board's office, but instead this is to be made available at the time of counselling.
  - b. The candidate must note that after submission of Willingness, neither it can be withdrawn nor any request for refund / chargeback of paid counselling fee will be entertained.
  - c. Board will not be responsible for any interruption in Internet / Banking system. Therefore the candidates must not wait for last date and complete all procedure before due date.
  - d. If any candidate does the payment of Security Deposit, but due to any technical issue the payment does not reflect and the amount got deducted from their bank account and even if due to any technical error sms or mail on their Registered Mobile and email id goes as "Application form submitted successfully" then in this case candidates are advised not to wait for payment updation instead do re-payment of Security Deposit else neither your application form nor candidature will be accepted.
  - e. Final Merit list will be prepared after scrutinising the candidate's submitted data from the data provided by National Testing Agency / Health Deptt., Govt. of Bihar and also under the rulese regulations of Hon'ble court, MCC and BCECEB.
  - f. The Rank Card / Merit List will be published on the Board's Website on scheduled date as notified through concerned advertisement.
  - g. Candidates are advised to confirm the Fee structure / any other additional Fee for the Pvt. Colleges before submission of Willingness. As Pvt. Colleges have high Fee structure, therefore candidates must confirm the Fee structure before Submission of Willingness from either the website of BCECE Board or concerned colleges. BCECE Board takes no responsibility of the fee structure of the colleges and will not entertain any complain regarding Fee structure.
  - h. NRI Candidates must note that as per notification of DGHS, New Delhi Ref. U-11011/05/2023-MEC Dated 06.10.2023, candidate who wants to claim benefit for NRI quota should select "NRI" at the time

of editing of online Application Form UGMAC-2024 and should submit the following documents with the required affidavit enclosed with the above notification as Annexure-1 at the time of document verification, otherwise they will not be eligible for NRI quota.

- \* Documents claiming that the sponsorer is an NRI (Passport, Visa of the sponsorer).
- \* Relationship of NRI with the candidate as per the court orders of The Hon'ble Supreme Court of India in case W.P.(c) No. 689/2017-Consortium of Deemed Universities in Karnataka (CODEUNIK) and Ans. Vs Union of India & Ors. Dated 22-08-2017.
- \* Duly notarized Affidavit from the sponsorer that he/she will sponsor the entire course fee of the candidate and the relationship of the sponsorer with the candidate is in accordance with the above mentioned court order.
- \* Embassy Certificate of the Sponsorer (Certificate from the Consulate).
- \* NEET Score Card of the candidate.

12. DQ candidates must note that they have to submit DQ certificate issued by only authorised Centres / Institutes on prescribed proforma as per para-3.6.3 (Annexure-5, 6, 7) of the prospectus of UGMAC-2024 at the time of counselling / document verification. For this, after filling and downloading the hard copy of online application form, candidates must consult any concerned authorised Medical College / Centre / Institute with the downloaded online application form for disability test for obtaining disability certificate.

Certificate issued from any other Institutes / Centres except above will not be entertained, for which the candidate will himself be responsible.
