### **Kind Attention: NRI Candidates for UG Counselling 2025(MBBS/BDS Seats).**

In reference to the earlier notice dated 02.08.2025, attached below is the list of the candidates found to be eligible for filling NRI choices after due scrutinization by the committee, of the documents, as provided by the candidates.

It is to inform the candidates that the allotment of seats under the **NRI Category** will be conducted based on the following **priority system**:

- **Priority 1:**
  - **NRI Candidates**
  - **Children of NRIs**
- **Priority 2:**
  - **First-degree relatives** of NRI wards.
  - **Second-degree relatives** of NRI wards.

The allotment process will be carried out in sequential order, giving preference to **Priority 1 candidates** first, followed by **Priority 2 candidates**, subject to seat availability.

The list is provisional and Candidates are advised to ensure that all required original documents (proof of NRI status, relationship certificates, etc.) are submitted correctly at the time of reporting at the allotted medical college and in case there is deficiency of documents, the college can cancel the seat allotment
