1. Online Registration & Submission of Application-cum-Choice filling after Round-2 are invited from such qualified, eligible & interested NEET(UG)-2026 candidates for appearing in the Round-3 Online Counselling of Under Graduate Medical Admission Counselling (UGMAC)-2026, who have not done the Registration and submission of Online Application or who has completed their registration process but did not duly submit Online Application with payment of requisite Counselling Fee & Security Deposit against Adv. No. BCECEB(UGMAC)-2026/01 & 2026/02 Dated 07.08.2026, 2026/05 Dated 11.09.2026, 2026/07 Dated 15.09.2026 and 2026/08 Dated 17.09.2026 and are not admitted in any Medical / Dental Colleges of India, for admission to the first year UG Medical / Dental Courses (MBBS / BDS) in Government / Private Medical / Dental Colleges and B.V.Sc. & A.H. / B.F.Sc. courses in Govt. Veterinary / Fisheries Colleges of Bihar state based on the Rank of UGMAC-2026 prepared on the basis of AIR of NEET(UG)-2026 on the basis of vacant seats available after admission on the basis of UGMAC-2026 Online Round-2 Counselling held from 27.09.2026 to 29.09.2026.

Consent is also invited from eligible candidates who have already duly submitted the Online Application form earlier and fall under the condition mentioned in para-17.

3. **Round-3 Counselling will be conducted Online.**

4. Updated Seat Matrix of vacancies after completion of Round-2 Counselling is available on Board's website: bceceboard.bihar.gov.in. If any further vacancies due to resignation etc. arise, the Updated Seat Matrix will be uploaded on the Board's website. The candidate must see it before Online Registration & Submission of Application-cum-Choice filling / submitting their Consent / editing of choices for Online Counselling.
5. Due to Upgradation of Round-2 candidates virtual vacancy may arise for Round-3 Counselling. So, candidates eligible for Round-3 Counselling are advised to do Online Registration & Submission of Application-cum-Choice filling / submit their Consent / Edit their choices by keeping this fact in their mind.
6. Such candidates who have registered themselves for UGMAC-2026 but have joined / taken admission on the basis of AIQ (up to Round-3 Counselling) are not eligible for UGMAC-2026 Round-3 and further counselling. Hence, they need not to do any activity for participating in Round-3 Counselling. If any such candidates are included in the weeding out list shared by MCC, they will not be eligible for Round-3 seat allotment process and if holding any seat through Round-1 / Round-2 Counselling will be cancelled with forfeiture of Security Deposit amount. The candidate will have no claim on it and no any request will be entertained in this regard.

7. In the light of Adv.No. BCECEB(UGMAC)-2026/01 & 2026/02 Dated 07.08.2026, 2026/05 Dated 11.09.2026, 2026/07 Dated 15.09.2026 and 2026/08 Dated 17.09.2026, candidates who have been allotted a seat and has taken admission finally by verifying their documents on their respective Seat / Institution on the basis of Round-1 / Round-2 Counselling are not eligible for UGMAC-2026 Round-3 Counselling.
8. Eligibility criteria, instructions and other details are available in the Prospectus of UGMAC-2026 which can be downloaded from the Board's website bceceboard.bihar.gov.in by clicking on the link "UGMAC-2026" under Prospectus Section.
9. **For Online Registration & Submission of Application-cum-Choice filling** click on "Online Portal of UGMAC-2026" and follow the instructions as given below;

i. **Step-One (Registration):**

For Registration, candidate will have to authenticate their identity by giving NEET(UG)-2026 Roll No., Candidate's Name and Date of Birth as appearing on the computer screen. After Identity / Data authentication, an OTP will be sent to candidate's registered Mobile No. and Email Address as provided during submission of NEET(UG)-2026 Application Form invited by NTA. **No request will be entertained to change / update the Mobile No. / Email Address throughout of the session before / after successful Registration.** While doing the registration for filling the online application form, he / she is also required to create password. After successful submission of the Registration details an UGMAC ID will be generated and it will be used to complete the remaining steps of the application form and will also be required for all future reference / correspondence. To complete the remaining steps of the application form candidate will have to login their account by entering their NEET(UG)-2026 Roll No. & Password and will process the further activities to duly submit their Online Application Form. The candidate must keep the password confidential, otherwise BCECE Board will not be responsible for any consequences.

ii. **Step-Two (Multi-Step Application Form):**

(a) **Personal Information:**

After successful registration, the candidate should again "Sign in" to his account and thereafter complete the required entries regarding personal information appeared on the computer screen. Then click on "Save & Continue" button.

(b) **Contact Details:**

After successful completion of Personal Information candidate have to submit their Permanent and Correspondence Address as appeared on the computer screen. Then click on "Save & Continue" button.

(c) **Educational Information:**

After successful completion of Contact Details candidate have to submit their Educational Information as appeared on the computer screen. Then click on "Save & Continue" button.

(d) **Upload Photo, Signature & Required Documents (if any):**

After successful completion of Educational Information candidate have to upload the Scanned copy of their highly contrast Colour Photograph, Signature & Required Documents (if any) at appropriate place as per the instructions provided on the computer screen. Then click on "Save & Continue" button. **(For further details kindly refer to the instructions uploaded on application portal regarding Photo & Signature uploading.)**

Note: It is mandatory to upload Ward quota certificate issued by the Registrar of Bihar Animal Science University, if applicable.

iii. **Step-Three (Application Preview & Final Submit):**

Candidates are advised to check their entries provided in Step-1 & Step-2 of the application form and if found any anomalies, click on "Back to Edit" button and rectify it. After rectification click on "Save & Continue" button so that the entries provided by them could get updated.

If all the information provided during filling of Online Application Form found to be OK on the preview page, click on "Final Submit & Proceed to Payment" button by giving the declaration and pay the Counselling Fee & Security Deposit as per instruction provided in Step-Four. If candidates do not do the final submission of the application form and payment of Counselling Fee & Security Deposit within prescribed date & time, then their filled-up application form will get rejected, for which candidate will be himself solely responsible and no any request will be entertained regarding this.

iv. **Step-Four (Payment of Counselling Fee & Security Deposit):**

After clicking "Final Submit & Proceed to Payment" button, complete the payment procedure according to instructions appeared on the computer screen regarding payment of Counselling Fee & Security Deposit. **Paid Counselling Fee is not refundable.**

Online Payment: Candidate will have to pay the Counselling Fee & Security Deposit through Online mode only i.e. Debit Card / Credit Card / Net banking / UPI, the candidate has to pay processing charge additional to Counselling Fee & Security Deposit for payment through online mode.

- (a) Candidate has to pay Rs. 1200/- (One Thousand Two Hundred Only) for UNRESERVED / EWS / BC / EBC category and Rs. 600/- (Six Hundred) only for SC / ST / DQ (of any category) candidates as non-refundable registration / counselling fee through online mode only e.g. by Credit card/Debit Card/Net Banking / UPI. But in case of Pvt. Colleges, all candidates have to pay Rs.1200/- only as non-refundable Registration & Counselling Fee.

Note: In case of Security Deposit paid as mentioned in above Serial No. (i) & (viii), if candidates want to take admission under Self-Financed Seats of B.V.Sc.&A.H. / B.F.Sc. courses will have to pay the security deposit amount of Rs. 50,000/-.

As per above table, the candidate has to pay the refundable security deposit, if applicable, through online mode only e.g. by Credit card / Debit Card / Net Banking / UPI at the time of Online Registration & Submission of Application-cum-Choice filling. The candidate has also to pay processing charge in addition to Counselling Fee & Security Deposit for payment through online mode.

Note: (i) If the amount paid as Counselling Fee & Security Deposit is debited from your account but the **fee transaction fails**, then in such case you **must re-pay** the desired full fee and ensure the payment. If your required Counselling fee & Security Deposit do not reflect in Board's account within the due date, your application form will remain incomplete and will be rejected due to which will not be eligible for participating in the counselling process.

Your failed transaction will be refunded to your account in due course.

v. Step-Five (Choice Filling):

After successful payment of Counselling Fee & Security Deposit candidate have to fill Choices of course and Institution / Colleges in order of preference. Candidate will have to click on **"Save Choices"** link and after then click on **"Choice Locking"** link to lock their filled-up choices before scheduled last date and time. If candidate lock their choices and again want to edit their filled-up choices, then candidate may modify their choices by clicking **"Unlock Choices"** link by authentication through their password and OTP sent on their registered Mobile No. / Email ID. Candidates are advised to Lock their filled-up choices before scheduled last date and time so that they could download or print their filled up and submitted choices. If candidate click on **"Save Choices"** link but does not lock their filled-up choices within scheduled last date and time, their choices will get automatically locked after last date and time of choice filling. Candidate will be allowed to download or take a print of their filled-up choices after locking of choices only.

Note: Choice Locking & Unlocking process will be done through OTP authentication only which will be sent on Registered Mobile No. / Email ID of the candidate. **The candidate must note that their Registered Mobile No. and Email ID cannot be changed in any circumstances.**

vi. Step-Six (Download Confirmation Page & Fee Receipt):

After successful payment of Counselling Fee & Security Deposit, candidates are advised to download the Confirmation Page & Fee Receipt and re-verify the entries printed on the confirmation page. **If found any discrepancy it may be corrected during the time of Online Registration & Submission of Application-cum-Choice filling** as per schedule mentioned in **"Important Dates"**. Finally download the Confirmation Page for future use.

vii. **Step-Seven (Download Choice Slip):**

After successful submission and locking of filled-up choices, candidate may download or take a print of their filled-up choices by clicking “**View Filled Choices**” link available on UGMAC-2026 portal dashboard.

10. **Editing / Correction of Application Form Data:**

- (i) The above-mentioned editing / rectification / correction opportunity will be available for only those candidates, who have successfully filled their online application form and made the payment successfully within due date.
- (ii) For making rectification / correction / editing in online submitted application, the candidate will have to login to his / her account using their Roll No. & Password provided during the time of Registration. After successful login candidate will click on the link “**Edit your Online Filled Application Form**”. Candidate will have to give their consent to Edit / Correct their previous filled Application Form data which will be authenticated through their password and OTP sent on their registered Mobile No. / Email ID. If OTP gets verified, the candidate will be able to edit/correct their filled-up Application Form data and do the following;
 - (a) Candidate may either edit/correct any data of his/her Application Form or not edit/correct any data of his/her Application Form but will have to save the Application Form finally by clicking “**Final Submit**” button visible on the Preview page of the Application. After Successful submission / Successful updating of payment status on application server, the edited Application Form will be treated as final. The filled-up choices will not get “**Null & Void**” and candidate will have the facility to edit the filled-up choices and will save the choices by clicking “**Save Choices**” link and after that to lock the choices by clicking “**Choice Locking**” link so that printout of finally filled-up and submitted choices could be obtained with proper validation of choices as per eligibility of finally submitted edited data.
 - (b) (i) If candidate either edit/correct any data of his/her Application Form or does not edit/correct any data of his/her Application Form and does not save the Application Form finally by clicking “**Final Submit**” button visible on the Preview page of the Application, then Application Form will be treated as incomplete and will not be eligible for seat allotment process.
 - (ii) If candidate edit/correct any data of his/her Application Form **due to which additional fee payment condition arises** then candidate has to pay the required fees but if he/she does not pay the required fee by saving the Application Form finally by clicking “**Final submit**” button visible on the Preview page of the Application, then Application Form will be treated as incomplete and will not be eligible for seat allotment process.

If candidate finally submit the Application Form successfully in the light of above process, candidate will have the facility to edit the filled-up choices and to save the choices by clicking “**Save Choices**” link and after that to lock the choices by clicking “**Choice Locking**” link so that printout of finally filled-up and submitted choices could be obtained with proper validation of choices as per eligibility of finally submitted edited data.

- (c) Due to Editing / Correction of data, if any additional Fee payment condition arises then candidate will have to re-pay the desired full-fee of Counselling Fee & Security Deposit afresh and ensure the payment. Such candidate’s previously paid amount of Counselling Fee & Security Deposit will be refunded back to their account through the same mode by which they had done the payment.
 - (iii) After successful submission of edited Application Form and Filling/Editing of Choices, candidate will have to lock their choices so that they could download or print their filled-up choices.
 - (iv) If any candidate locked their filled-up choices and after then wants to Edit / Correct Application Form data, then first of all he / she has to unlock their choices. After Un-Locking of Choices, he / she will click on the link “**Edit your Online Filled Application Form**”. After editing of data, candidate must ensure their filled-up choices and get it locked for seat allotment process. (For details refer to choice filling process of this advertisement.)
11. Final Merit list will be prepared after scrutinising the data of NEET(UG)-2026 provided by NTA through Health Department, Govt. of Bihar and also under the rules & regulations of Hon’ble Court, MCC and BCECEB. On the basis of AIR obtained in NEET(UG)-2026, Rank Card of all eligible candidates who will fill Online Application Form and pay the Counselling Fee & Security Deposit or given their consent as per advertisement published earlier in this regard will be uploaded on Board’s website “bceceboard.bihar.gov.in” on **06.10.2026**. Candidates are advised to download their Rank Card of UGMAC-2026 by clicking the link “**Round-3 Rank Card of UGMAC-2026**” by submitting their UGMAC ID and Date of Birth.
12. a. The candidates are required to fill up the reservation category very carefully taking into consideration the reservation policy/ rules / category as specified and applicable in the State of Bihar on the date of starting the process of online submission of the prescribed application form for UGMAC-2026. Details of Reservation Rule may be seen in Para-3 of UGMAC-2026 Prospectus.
 - b. Confirmation Page (Application Form) need not to be send to Board’s office, but instead this is to be made available at the time of counselling.
 - c. After completing the above procedure and after the date of editing and submitting the online application form, there is no provision for any change or modification in the same.
 - d. The candidate must note that after submission of online application form, neither it can be withdrawn nor any request for refund / chargeback of paid counselling fee & Security Deposit will be entertained.
 - e. Board will not be responsible for any interruption in Internet / Banking system. Therefore, the candidates must not wait for last date and complete all procedure before due date.
 - f. If any candidate does the payment of Counselling Fee / Security Deposit, but due to any technical issue the payment does not reflect and the amount got deducted from their bank account and even if due to any technical error SMS or mail on their Registered Mobile and email id goes as “**Application form submitted successfully**” then in this case

candidates are advised not to wait for payment updation instead do re-payment of counselling Fee/ Security Deposit else neither your application form nor candidature will be accepted.

- g. No other chance will be given to any candidate for Registration and submission of online application after due date for online submission of application.
- h. NRI Candidates must note that as per notification of DGHS (MCC), New Delhi Ref. U-11011/07/2025 Dated 27.05.2026, candidate who want to claim benefit for NRI quota should select "NRI" at the time of online Registration of UGMAC-2026 and should upload the following documents with required affidavit / Declaration enclosed with the above notification at the time of Online Registration & Submission of Application-cum-Choice filling and to submit original uploaded certificate at the time of Document Verification, otherwise he / she will not be eligible for NRI quota.

Category I: NRI Candidate / Parents / Real Brother / Real Sister

- * NEET Score Card of candidate issued by NTA.
- * Valid Passport of candidate.
- * NRI Certificate issued by the Competent Authority (Embassy / India Consulate).
- * Affidavit (Notarized) by the NRI parent/ Real Brother/ Real Sister stating that they will sponsor the entire course fee and living expenses of the candidate (son/ daughter) during the period of study supported by NRE Bank Account Passbook.
- * Relationship to be verified by competent revenue authority officer (Tehsildar/ Government Officer). In cases of first degree relative as per point 1 and 2 in the principles laid in Anshul Tomar vs. State of MP W.P No.13393 of 2007.

Category II: Indian to NRI (Candidates who filled their category as Indian category in NEET UG form and now want to get converted to NRI category for counselling.

- * NEET Score Card of candidate issued by NTA.
- * Valid Passport of candidate.
- * Valid Passport of legal guardian.
- * NRI Certificate of the guardian issued by the Competent Authority (Embassy / India Consulate).
- * In case of sponsorship by a legal guardian.
- * Affidavit (Notarized) by the legal guardian that he/she will sponsor the entire course fee and living expenses of the candidate during the period of study duly supported by NRE (Non-Resident External) Bank Account Passbook.

As per notice dated 27.05.2026, Applicants are eligible for admission under the NRI quota if they produce documentation issued by **Indian Mission / MEA** for being an **NRI / Child of an NRI / Ward of an NRI** (minor under Bonafide guardianship).

- * **For Eligibility Criteria and other details, required Documents for admission on NRI Quota, candidates are advised to see 'Notice to Candidates Admission Procedure under NRI Quota issued by MCC dt. 27.05.2026 and also Information Bulleting & Counselling Scheme of NEET-UG Counselling 2026' which can be seen on MCC Official Website.**

13. DQ candidates must note that they have to upload DQ certificate issued by only authorised Centres / Institutes on prescribed proforma as per para-3.6.3 (Annexure-5, 6, 7) of the prospectus of UGMAC-2026 or as per prescribed proforma of the NEET-UG 2026 Information Bulleting, along with UDID Card & Affidavit by the candidate at the time of downloading provisional seat allotment order and have to submit original uploaded certificate at the time of Document Verification, otherwise he / she will not be eligible for DQ quota.

Certificate issued from any other Institutes / Centres except above will not be entertained, for which the candidate will himself be responsible.

- * **For Eligibility Criteria and other details, required Documents for admission on (DQ) Quota, candidates are advised to see 'Chapter 4: Persons with Benchmark Disabilities (PwBD) of Information Bulleting & Counselling Scheme of NEET(UG) Counselling 2026' which can be seen on MCC Official Website.**

14. Float candidates of Round-2 Counselling who have successfully completed their Round-2 Counselling Document Verification process without any discrepancy, if wants to edit their previous filled choices will have to login to their account with their NEET(UG)-2026 Roll No. and Password by clicking the link "**Online Portal of UGMAC-2026**" available on Board's Website. Such candidates will be eligible for Round-3 Counselling and will have the facility to **edit their previous filled choices for Round-3 Counselling but cannot remove / delete their Round-2 Counselling allotted choice from the choice list**. The candidates will have the facility to swap the positioning of their Round-2 Counselling allotted choice. Such candidates will not have the **facility to edit / correct their previous filled Application Form data in any circumstances**.

15. Float candidates of Round-2 Counselling may Resign / Surrender their Round-2 Counselling allotted seat with forfeiture of security deposit amount through online mode only by login to their Counselling Portal account within Scheduled period as mentioned in "**Important Dates**" by clicking "**Withdrawal from Counselling**" button. Such candidates allotted seat will get cancelled and their filled choices will become "**Null & Void**" but will be eligible for Round-3 Counselling by giving their Consent. The candidate must ensure to download the system generated Withdrawal Slip through the counselling portal.

16. Freeze (admitted) candidates who has taken admission through Round-1 / Round-2 Counselling may resign their Round-1 / Round-2 Counselling allotted seat with forfeiture of security deposit amount within scheduled period as mentioned in “**Important Dates**” by visiting physically to the Admitted / Allotted institute by providing the reason of resignation to the Principal of Admitted / Allotted institute. The candidate must ensure to receive the system generated Resignation Slip through Board’s Counselling Portal which should be duly signed by the Principal / Admission In-charge of the allotted institute. Such candidates allotted seat will get cancelled and their filled choices will become “**Null & Void**” but will be eligible for Round-3 Counselling by giving their Consent.
 17. (a) Such candidates who have duly submitted Online Application with payment of requisite Counselling Fee & Security Deposit vide Adv. No. BCECEB(UGMAC)-2026/01 & 2026/02 Dated 07.08.2026, 2026/05 Dated 11.09.2026, 2026/07 Dated 15.09.2026 and 2026/08 Dated 17.09.2026, but did not fill their choices due to any reason / have not been allotted any seat for UG courses through Round-1 Counselling / who have been allotted a seat in UG course through Round-1 Counselling but as per rule allotted seat gets cancelled due to any reason (i.e. Free-Exit / Resigned / Withdrawal / non-compliance of Discrepancy in Data) as well as not participated in Round-2 Counselling or Participated in Round-2 Counselling but has not been allotted any seat in UG Course, if wants to participate in Round-3 Counselling then they have to login to their account with their NEET(UG)-2026 Roll No. and Password by clicking the link “**Online Portal of UGMAC-2026**” available on Board’s Website and will have to give their Consent.
 - (b) All “**Freeze**” or “**Float**” candidates who have been allotted seat (**Fresh / Retained / Upgraded**) through Round-2 Counselling but as per rule allotted seat gets cancelled and choices become “**Null & Void**” due to non-compliance of Discrepancy in data, if wants to participate in Round-3 Counselling then they have to login to their account with their NEET(UG)-2026 Roll No. and Password by clicking the link “**Online Portal of UGMAC-2026**” available on Board’s Website and will have to give their Consent.
 - (c) All “**Freeze**” or “**Float**” candidates who have been allotted seat (**Fresh / Retained / Upgraded**) through Round-2 Counselling but as per rule allotted seat gets cancelled and choices become “**Null & Void**” due to any reason (i.e. Not Reported / Resigned / Withdrawal) and their paid Security Deposit amount gets forfeited, if wants to participate in Round-3 Counselling then they have to login to their account with their NEET(UG)-2026 Roll No. and Password by clicking the link “**Online Portal of UGMAC-2026**” available on Board’s Website and will have to give their Consent with fresh payment of Counselling Fee & Security Deposit.
