PROSPECTUS

As per the letter no. सं.सं.-16/एम.1-18/2024-1026 (आ.चि.) dated 18.09.2024 of the Deptt. of Health, Govt. of Bihar the nominations or allotment of seats for admission in Post Graduate Medical Homoeopathy courses in R.B.T.S. Govt. Homoeopathy Medical College & Hospital, Muzaffarpur & GD Memorial Homoeopathic Medical College & Hospital, Patna (Private) shall be made according to merit-cum-choice on the basis of the Competitive Test as conducted by All India Ayush Post Graduate Entrance Test (AIAPGET)-2024, Department of Ayush Govt. of India, New Delhi .

1. SHORT TITLE, EXTENT AND COMMENCEMENT :

- (i) This Prospectus may be called 'Post Graduate Medical Homoeopathy Admission Counselling (Ayush) Prospectus-2024.
- (ii) It shall extend to the whole of the State of Bihar.
- (iii) It shall come into force at once.

2. DEFINITIONS :

- (i) 'College'—Means Government/ Private Homoeopathic Medical College and Hospital in the State of Bihar.
- (ii) 'Course'—Means Post Graduate Homoeopathy Medical courses of study i.e. MD (Hom) courses.
- (iii) 'Examination'— AIAPGET-2024.
- (iv) 'Board'— Means Bihar Combined Entrance Competitive Examination Board, Government of Bihar.
- (v) 'Government'— Means State Government of Bihar.
- (vi) 'Controller of Examination'- Means Controller of Examination, Bihar Combined Entrance Competitive Examination Board, appointed by the Government.
- (vii) 'He' includes 'She'.
- (viii) 'Bihar' - Means Bihar after reorganisation as defined under section-4 of the Bihar Reorganisation Act-2000.
- (ix) 'University'- Means The Bihar University of Health Sciences.

3. Admission :

Nomination for admission in R.B.T.S. Govt. Homoeopathic Medical College & Hospital, Muzaffarpur &

GD Memorial Homoeopathic Medical College & Hospital, Patna (Private) MD (Hom) Degree Courses shall be made on merit-cum-choice based on AIAPGET-2024 conducted by All India Ayush Post Graduate Entrance Test (AIAPGET)-2024.

5. QUALIFICATION & ELIGIBILITY FOR MD (HOMOEOPATHY) COURSE GROUP:

5.1 Educational qualification & Eligibility (As modified in compliance with the directive of the Hon'ble Patna High Court, Patna in CWJC No. 15504/2018) :

i.(a) For 50% seats reservation on the basis of institutional preference :

The candidates must have passed the B.H.M.S. Examination from Govt. Homoeopathic College of Bihar State included in the Second schedule of Central Council of Homoeopathy (Now know as National Commission for Homoeopathy), India and must be qualified on the basis of All India Ayush Post Graduate Entrance Test (AIAPGET)-2024.

(b) For rest 50% open seats :

The candidates must have passed the B.H.M.S. Examination from any Homoeopathic College included in the Second schedule of Central Council of Homoeopathy (Now know as National Commission for Homoeopathy), India and must be permanent resident of Bihar and must be qualified on the basis of All India Ayush Post Graduate Entrance Test (AIAPGET)-2024 **and permanent Resident / Domicile of Bihar.**

ii. The candidates who are AIAPGET-2024 qualified and are permanent residents / domiciled of Bihar and have been admitted in BHMS course on the basis of competitive examination conducted on behalf of Govt. of Bihar before the bifurcation of Bihar i.e. 15.11.2000 in Homoeopathic College situated in Jharkhand and have obtained the degree of BHMS are also eligible for counselling / admission in academic session 2024 in this PG Homoeopathy Course.

iii. Twelve months Compulsory Rotatory Internship Completion Certificate:

NCISM is in receipt of representations from students, institutions, universities as well as State Government regarding extension of cutoff date of internship completion date to make them eligible for AIAPGET 2024-25. The representation were thoroughly considered in joint commission meeting of NCISM & NCH held on

6th May, 2024; the cutoff date of internship completion date has already been extended to 31st July from 30th June, 2024.

Candidate who have completed their Twelve months compulsory Rotatory Internship but not submitted his / her compulsory Internship completion certificate at the time of admission / reporting for Round-1 and Round-2 of PG counselling are instructed to submit an Undertaking (Annexure-1E), counter-signed by the Head of the Institution (the institution from where internship is being pursued). Further, such candidates must submit their original Compulsory Rotatory Internship Completion Certificate at the allotted institute on or before the last date for reporting to the allotted institutes specified by the respective counselling authority for 2nd round of PG counselling. Otherwise, his / her admission shall stand cancelled. The vacant seats thus arised shall be added to 3rd round counselling.

iv. BHMS Degree Certificate / Provisional Degree Certificate.

If a candidate not able to produce a valid Provisional Degree Certificate at the time of admission / reporting for Round-1 and Round-2 of PG counselling, in that case, the candidate shall submit an undertaking stating that he / she will submit the valid Provisional Degree Certificate at the allotted institute on or before the commencement date of PG course for the academic session 2024-25 as already informed by NCISM / NCH.

v. Permanent Registration Certificate issued by NCH / CCH / Homoeopathy Board:

Candidate who have completed their Twelve months Compulsory Rotatory Internship at the time of admission / reporting for Round-1 and Round-2 of PG counselling, are instructed to submit a copy of the Provisional Registration Certificate at the time of reporting. Further, such candidates shall submit their original Permanent Registration Certificate at the allotted institute on or before the commencement date of PG course (i.e. 01st December, 2024) for the academic session 2024-25 as already informed by NCISM / NCH.

vi. Transfer Certificate / College Leaving Certificate:

Candidate who have not completed their Twelve months Compulsory Rotatory Internship at the time of admission / reporting for Round-1 and Round-2 of PG counselling, are instructed to submit an undertaking stating that he / she will submit the Transfer Certificate / College Leaving Certificate on or before the last date for reporting to the allotted institutes as specified by the respective counselling authority for 2nd round of PG counselling at the allotted institute.

5.2 Residential :

- (i) The candidates must be a citizen of India.
- (ii) The candidates must be permanent Resident / Domicile of Bihar.
- (iii) **The candidates must note that he / she has to produce Residential Certificate issued by the competent authority and also Certificate from the Head of the Institution where the candidate studied last mentioning permanent residence as per the admission register BHMS course.**

5.3 Age Limit :

There is no maximum age limit for appearing at PG Medical Admission Counselling (Ayush)-2024 for MD (Hom).

5.4 No Objection Certificate :

- (i) A candidate who is an employee either in Government or elsewhere will be allowed to appear at the test only if he produces a certificate of "no objection" from his employer with the condition that if selected he will be granted study leave to pursue the course. However a candidate who is an employee of Government of Bihar shall be issued admit order provisionally in the absence of such "no objection" certificate. But on selection, he will have to produce relieving certificate from his controlling officer. Otherwise, he is required to furnish an undertaking / affidavit (first class magistrate) that in case he is selected he shall resign from the service and shall undertake the studies as a full time student. Such affidavit/ undertaking is to be filed along with the Application Form. The relieving letter by the employer shall be submitted on or before the date of admission.

- (ii) A candidate who is already admitted in MD (Homeo) Ayush Courses in Govt. Colleges or else where will be allowed to appear at the counselling only if he/ she produce a certificate of NOC from his / her institute.

5.5 Training :

- (i) All the candidates called for counselling/ interview, if selected, shall have to be registered with Bihar State Homeopathic Board within one month from the date of the admission in MD (Hom) Course and will also have to be registered by the University concerned within the prescribed period by that University. The registered candidates will undergo whole-time course for 3 years for degree courses, from the date of their admission.
- (ii) No admission or readjustment will be done after the last date of admission as fixed in compliance with the requirement of National Commission for Homoeopathy, India. Thereafter, the seats remaining vacant if any, shall be treated to have lapsed. No transfer/ migration will be permissible after admission.
- (iii) An admitted candidate on the basis of the counselling of PGMAC (AYUSH)-2024 (HOMOE), shall automatically forfeit his claim to continue in the previous P.G.Course for which he was originally registered. His name registered for that P.G.Course will be cancelled and upon his/ her admission to the new P.G.Course on the basis of PGMAC (AYUSH)-2024 (HOMOE), he will have to get registered with the university concerned for that P.G.Course only and he has to refund the entire amount of stipend already paid to him for the previous P.G.Course to the previous Institution and a certificate to this effect is to be produced at the time of counselling to the new Course, allowed to him.
- (iv) Admitted candidates who remain absent continuously for more than 2 months are liable to forfeit his claim to continue in the previous PG Medical course for which he was originally registered. His name registered for that PG Medical course will be cancelled and upon his / her admission to this new PG Medical course on the basis of PGMAC (AYUSH)-2024 for MD (Hom) he will have to get registered with the university concerned for that PG Medical course only and he has to refund the entire amount of stipend already paid to him for the previous PG Medical course to this previous institution and a certificate to this is to be produced at the time of counselling to the new course allotted to him.

6. RESERVATION :

- (A) (i) For the selection of candidates for admission in Post Graduate Degree of MD (Hom) Course in RBTS Govt. Homoeo Medical College & Hospital, Muzaffarpur, the reservation Policy/ Rules of the Government of Bihar prevailing on the date of Online submission of Application Forms for PG Medical Admission Counselling (Ayush)-2024 will be applicable.

Accordingly the reservation categories will be determined on the basis of the lists of SC, ST, EBC and BC as approved by the Govt. of Bihar and applicable on the date of the online submission of application forms for allotment of PG Medical (Homoeo) seats on the basis of PG Medical Counselling (Ayush) based on AIAPGET-2024.

- (ii) For the Candidates, who are permanent residents of Bihar State, reservation of seats for various Categories as per the policy of the Government of Bihar prevailing at the date of PG Medical Admission Counselling (Ayush)-2024 is as given below –

The remaining 40% unreserved seats will be considered as Unreserved (UR) Category seats.

(माननीय पटना उच्च न्यायालय, पटना के आदेश दिनांक 20.06.2024 द्वारा बिहार आरक्षण अधिनियम 18, 2023 तथा बिहार आरक्षण अधिनियम 19, 2023 को set aside किये जाने के फलस्वरूप पूर्व प्रवृत्त आरक्षण के प्रावधान लागू होंगे। माननीय उच्च न्यायालय, पटना द्वारा पारित इस न्यायादेश के विरुद्ध राज्य सरकार द्वारा माननीय सर्वोच्च न्यायालय, नई दिल्ली में SLP(C) No.-014086/2024, 014425/2024, 014096/2024, 014329/2024, 014079/2024, 014051/2024, 014132/2024, 014094/2024, 014081/2024 एवं 14430/2024 दायर किया गया है। माननीय सर्वोच्च न्यायालय में दायर एस.एल.पी. में पारित आदेश के फलाफल से आरक्षण का प्रावधान प्रभावित होगा।)

नोट – (a) * आर्थिक रूप से कमजोर वर्ग के लिए 10 प्रतिशत आरक्षण बिहार सरकार द्वारा प्रकाशित असाधारण अंक गजट (संख्या- पटना 284) पटना, दिनांक 26.02.2019 के अनुसार होगा।

(b) सामान्य प्रशासन विभाग, बिहार, पटना के संकल्प ज्ञापांक-12722 दिनांक 12.09.2014 के आलोक में किन्नर / कोथी / हिजड़ा/ ट्रांसजेंडर व्यक्तियों को पिछड़े वर्गों को मिलने वाले आरक्षण का लाभ देय होगा।

(c) बिहार स्वास्थ्य विज्ञान विश्वविद्यालय अधिनियम-2021 की कंडिका-8 में उल्लेखित प्रावधान के आलोक में बिहार राज्य अंतर्गत शैक्षणिक संस्थानों में नामांकन हेतु समय-समय पर लागू उर्ध्वांचर आरक्षण के प्रावधानों को अक्षुण्ण रखते हुए विश्वविद्यालय से संबद्ध प्रत्येक संस्थान एवं महाविद्यालय में पाठ्यक्रमवार एवं कोटिवार कुल सीटों का एक तिहाई महिला अभ्यर्थियों के नामांकन के लिए क्षैतिज रूप से आरक्षित रहेगी। स्नातकोत्तर पाठ्यक्रम में यह आरक्षण राज्य स्तर पर विशेषज्ञतावार लागू होगा।

परन्तु यह कि इस लाभ के लिए केवल बिहार राज्य की निवासी महिलायें ही पात्र होगी। योग्य महिला अभ्यर्थियों की अनुपलब्धता की स्थिति में उसी शैक्षणिक सत्र में रिक्त सीटों को संगत कोटि (आरक्षित / गैर आरक्षित) के पुरुष अभ्यर्थियों से भरा जा सकेगा। इन प्रावधानों को लागू करने हेतु सरकार द्वारा समय-समय पर यथोपेक्षित आदेश निर्गत किया जा सकेगा।

(iii) For the Candidates who are not the permanent resident of the State of Bihar, seats earmarked for the reserved categories as enumerated in Sl. No. 6A(ii) above, will not be admissible, vide Department of General Administration, Government of Bihar letter no. 11/आ0-विविध-50/2011 सा०- 2710 dated 26.08.2011. They will be considered against Unreserved (UR) Category seats only.

(iv) Candidates of reserved categories competing in Unreserved (UR) will not be counted against reserved category seats. Selection of the candidates in the unreserved category will also be on merit. Placement of Reserved Category candidates will be done as per the Government resolution/ orders applicable at the time of starting the online submission of the Application Form for PG Medical Admission Counselling (Ayush)-2024. Candidates of reserved category competing in Unreserved (UR) will have the option for Open Seats as well as the concerned reserved category seats for purposes of placements, but the seat of reserved category exhausted due to their option will be compensated from seats of Unreserved (UR).

(v) A candidate claiming admission on seats reserved for SC/ ST/ EBC/ BC/ RCG will have to furnish (a) Residential certificate (b) Caste certificate issued by CO / Revenue Officer of the area of his/her permanent residence in the State of Bihar, as mentioned in the Application Form for appearing in PG Medical Admission Counselling (Ayush) 2024.

N.B. :(a) Caste and Residential Certificates issued by other than CO / Revenue Officer will not be entertained and will lead to rejection of his/ her application.

The Residential Certificate must mention that the candidate is a permanent resident (स्थायी निवासी) of Bihar giving his complete address, letter no. and date of issue. Certificates mentioning that the candidate is resident (निवासी) / temporary resident (अस्थायी निवासी) or incomplete in any respect will not be accepted.

(b) Caste certificate issued on the basis of the Caste of the Husband / Wife of the candidate is not acceptable. Caste Certificate issued on the basis of the caste of his / her father will only be accepted.

(c) The spelling of the name of the candidate written in his application form of AIAPGET-2024 must be the same as written in his matriculation and other certificates. Any difference will subject to the decision of the concerned authority of the Deptt. of Health, Govt. of Bihar.

- (vi) The category, which a candidate claims for reservation in the space provided for this purpose in the Application Form and the Residential certificate and Caste certificate which he submits as per para (v) above, will be accepted for the PG Medical Admission Counselling (Ayush)-2024 for MD (Hom) and the allotment of seats will be made on that basis provided the same are in conformity with the rank list of AIAPGET-2024. Once the application form is accepted, no change will be allowed. In case the category claimed by a candidate and mentioned in the specified space in application form for appearing in counselling differs from that mentioned in the merit list as provided by the Deptt. of Health, Govt of Bihar based on AIAPGET-2024, then the category as mentioned in the Merit List will be treated as final. If a candidate does not mention the category at the specified space in application form or does not submit the proper caste certificate in support of his claim for the reserved category benefit then he will be treated in Unreserved (UR) category. The responsibility of losing his reservation claim due to his mistake/ carelessness will entirely be his own.

(B) **Reserved Seats under Disabled Quota (DQ) :**

- (a) For disabled candidates, 5% out of the available seats in each Institution, are reserved under "Disable Quota". Such reserved seats are included in the total number of the available seats.

In this connection, if the state Government issues any other Government order before publishing the merit list for counselling / interview for the purposes of the seat allotment, then reservation rules according to the same Government order, will be applicable for admission under Disable Quota subject to his DQ (or PH) status is mentioned in merit list of AIAPGET-2024.

- (b) Each disabled candidate is required to mention his claim in the specified space of his application form such DQ candidates have to submit DQ Certificate at the time of counselling / document verification in the light of regulation on Graduate Medical Education (1997) as amended up to 14.05.2019, in the prescribed performa as enclosed in Annexure-1A of the prospectus. As per decision taken by concerned Department and BCECE Board, the candidate have to produce disability certificate only from the authorized centres, the list of which are mentioned in Annexure-1B and 1C of this prospectus. No other Disability Certificate issued by any other centre will be acceptable in any conditions.

Original DQ Certificate issued by the authorized centre as per Annexure-1B and 1C has to submit at the time of Document Verification . Counselling otherwise they will not eligible for DQ seat. This DQ Certificate is valid only for admission in different courses on the basis of examination conducted by the BCECE Board. It cannot be used neither for any other purpose nor for admission in any other institutions whose examination / admission is not taken by the BCECE Board.

- (c) A disabled candidate may opt on the basis of merit rank list of AIAPGET-2024, any one of such courses for which his disability is within the limits of the acceptable disability standards and is not restrictive for opting the same. The admit order will be issued to the candidate after he is found otherwise medically fit. For such medical test an additional fee will be charged.
- (d) "Guidelines for admission against Disable Quota" is enclosed as Annexure-ID.

7. Procedure for Online Submission of Application Form, procurement of Prospectus and Counselling Fee : The Prospectus for appearing in PGMAC (Ayush) for MD(HOMEEO)-2024 can be downloaded Online from the BCECE Board's website : **bceceboard.bihar.gov.in** by clicking on the link "PGMAC (Ayush)-2024 [MD (HOMEEO)]" under Prospectus Section. After that click on "Online Application portal of PGMAC (Ayush) [MD (Homeeo)]-2024 and follow the instructions appearing on the computer screen.

- I. Step-One - Registration:** For registering, the candidates are required to fill the information asked in Step-One of the application form, appearing on the computer screen. Candidate must enter their AIAPGET-2024 Roll No. and then click on verify button and then enter their AIAPGET-2024 Application No. & Date of Birth as shown on the screen. If data gets verified, proceed for further process. Candidate while registering, must see that he/ she is giving his/her own email ID and Mobile no. because an OTP will be sent to their entered email ID and mobile no. for email ID and mobile no. verification. After successful verification of email ID and mobile no. and successful registration, the registered mobile no. and email ID can not be changed in the whole process of PGMAC (Ayush)-2024 Counselling in any circumstances. After successful Registration, candidate will receive a message of successful registration on their registered mobile no. and

email. After that, candidate will have to login to their account by entering their email ID and Password and will process the further activities to duly submit their online application form. The candidate must keep the password entered in Application Form confidential, otherwise BCECE Board will not be responsible for any changes in their data or any other complication etc. The email ID provided by the candidate during registration will be his “user name”.

II. Step-two - (Personal Information) : After successful registration and activating the account, the candidate should again “Sign in” to his account and thereafter complete the required entries regarding personal information on the computer screen. Then click on “Save & Continue” button.

III. Step-Three - (Upload Photo and Signature) : After entering the personal information, the candidate should upload his / her passport size photograph as uploaded in AIAPGET-2024 online application form and full signature in Hindi and English (Not in capital letter) after duly scanning the same. After uploading photo and signature click on “Save & Continue” button.

IV. Step-Four - (Educational Information): After uploading the scanned photo and signature the candidate should enter his / her educational information on the computer screen and click on “Save & Continue” button.

V. Step - Five- (Preview your application) : After entering educational information the candidate must verify all the information given by him / her while verifying given information in step-2, step-3 and step-4. If any information is found wrong, then the candidate should click “Back to Edit” button and make required corrections. Thereafter the candidate should click “Save & Continue” button so that entered information should be updated. If preview of application form is found to be correct, then the candidate give his / her Declaration and click the “Proceed to Payment” button so that he / she should pay Counselling Fee as per Step-Six.

VI. Step-Six (Payment of Counselling Fee and Security Deposit): After previewing the Application Form for submitting the same, candidate should click “Proceed to Payment” button and complete the payment procedure for counselling fee and security deposit according to instruction appeared on the computer screen. Counselling fee is not refundable.

(a) Candidate has to pay Rs. 2200/- (Two Thousand Two Hundred Only) for all categories i.d. Unreserved/ EWS / ST/ SC/ BC/EBC/ DQ candidates as **non refundable** registration / counselling fee through online mode only e.g. by Credit card/Debit Card/ Net Banking / UPI. The candidate has also to pay processing charge in addition to Counselling Fee for payment through online mode.

As per above table, the candidate has to pay the refundable security deposit through online mode only e.g. by Credit card/Debit Card/ Net Banking / UPI at the time of registration and submission of the application form. The candidate has also to pay processing charge in addition to Counselling / Registration Fee and Security Deposit for payment through online mode.

Note: (i) If the amount paid as Examination / Counselling fee is debited from your account but the fee transaction fails, then in such a case you must re-pay the desired full fee and ensure the payment. If your required Examination / Counselling fee do not reflect in Board's account within the due date, your application form will remain incomplete and you will not be eligible for Examination / Counselling.

Your failed deducted amount from bank will be refunded to your account.

Step - Seven (Downloading of Part- A & Part-B): After payment of Counselling/Registration Fee upto scheduled date and time, the candidate must download Hard Copy (Part-A & and Part-B) of online submitted Application Form and keep the same safely in his possession because it contains all informations provided by the candidate and the PGMAC (Ayush)-ID made available by the Board for further use during counselling.

Note: a. Hard copy of PART-A & PART-B need not to be send to Board's office, but instead this is to be made available at the time of counselling.

b. After completing the above procedure and after the date of editing and submitting the online application form, there is no provision for any change or modification in the same.

c. The candidate must note that after submission of online application form, neither it can be withdrawn nor any request for refund of paid counselling fee will be entertained.

- a) Merit list of all the qualified candidate as provided by the Deptt. of Health, Govt. of Bihar based on AIAPGET-2024 will be the basis for PGMAC(Ayush)-2024 (Homoeopathy/ Ayurveda/ Unani).
- b) There will be four (5) round of Counselling i.e. Round-1, Round-2, Round-3 and Stray Vacancy Round-1 & 2.
- c) All round Counselling i.e. Round-1, Round-2, Round-3 and Stray Vacancy round will be Online.
- d) For Round-3, Fresh Online Registration and Submission of Application Form For 3rd Round Online Counselling, Fresh online Registration & submission of Application Form, from those candidate who has not Registered and submitted Application Form of PGMAC(Ayush)-2024 (Homoeopathy/ Ayurveda/ Unani) earlier i.e. before 1st round Counselling, will be taken. Details will be made available through concerned advertisement.

- 10.2 (a) (i) On the basis of merit list of PGMAC(Ayush)-2024 (Homoeopathy/ Ayurveda/ Unani) of eligible candidate, the candidate has to fill his choices online for PGMAC(Ayush)-2024 (Homoeopathy/ Ayurveda/ Unani) counselling. Please note that choice filling facility will be available as per schedule published in concerned Advertisement. After completion of choice filling process, seat allotment result will be published on Board's website. In case candidate is allotted seat during 1st round seat allotment then he has to report physically at reporting centre for document verification. After document verification, if he is found eligible he will either take admission or go for free exit. But if he has given willingness for up-gradation during downloading of 1st round provisional seat allotment order then after document verification, he will wait for 2nd round seat allotment and his submitted document will be retained at reporting centre. But if his choice is upgraded in Round-2, then the candidate will have to join the college on allotted seat during second round.
- (ii) After publication of 1st round seat allotment result, the candidates who are allotted a seat shall download their provisional allotment order by login on counselling portal but before downloading of provisional allotment order, it is necessary for the candidates to give option for upgradation as 'Yes' or 'No'.

- (iii) The candidate who gets allotted a seat during Round-1 counselling and given their upgradation for Round-2 counselling as 'No', then candidate will have to report physically to their reporting centre within scheduled period as printed on the provisional allotment order of Round-1 counselling with all required original documents for Identity and document verification. After document verification, if the candidate is found eligible he will take admission with payment of requisite Fee and their all original documents will be retained at the reporting centre and candidate will be provided a Document Verification Slip of Round-1 counselling.
- (iv) In case the seat allotted in Round-1 Counselling is retained in Round-2 Counselling then the candidate will have to report physically to their reporting centre within scheduled period as printed on the provisionanl allotment order of Round-2 Counselling with their Round-1 document verification slip and will have to take admission with payment of requisite Fee.
- (v) In case of upgraded seat allotment in Round-2, the candidate will have to collect their all submitted original documents from Round-1 reporting centre and then will have to report physically to their reporting centre within scheduled period as printed on the provisional allotment order of Round-2 Counselling with all required documents in original and Round-1 document verification slip for Identity and Document Verification. After document verification, if the candidate is found eligible then their all original documents will be retained at the reporting centre and will have to take admission with payment of requisite Fee.

- (b) The candidate who got allotted a seat during Round-1 counselling and given their upgradation for Round-2 counselling **‘Yes’ or ‘No’** but due to any reason did not reported physically to their Reporting Centre within scheduled period as printed on the Provisional Allotment order of Round-1 counselling with all required documents in original for identity and Document Verification, then in such case their Round-1 allotted seat will be cancelled and will not be considered for upgradation in Round-2 counselling (if given their upgradation for Round-2 counselling as **‘Yes’**) but will be eligible for Fresh Choice Filling of Round-2 Counselling. Such candidates will also be treated as Free Exit from Round-1 Counselling.
- (c) After joining the allotted seat in Round-2, the candidate will not be eligible to participate in any further round of counselling.
- (d) Candidate who did not get any upgradation in Round-2 will continue to study in the same college and seat and he cannot resign the said seat in Round-2.
- (e) Allotment will be made through online mode for the all round counselling i.e. Round-1, Round-2, Round-3 and Stray Vacancy round.
- (f) Fresh choice filling / Modification can be done for Round-2 Counselling by all eligible following candidates;
 - (i) Who are included in the merit list of PGMAC(Ayush)-2024 (Homoeopathy/ Ayurveda/ Unani) and are eligible but did not completed the choice filling process on counselling portal for Round-1 Counselling.
 - (ii) Who have been allotted a seat in Round-1 Counselling and taken free exit within prescribed date.
 - (iii) Who have been allotted a seat in Round-1 Counselling either with upgradation **'Yes'** or **'No'** but not reported to reporting centre.
 - (iv) Who have been allotted a seat in Round-1 Counselling and given their upgradation as **'Yes'** as well as completed the process of document verification at reporting centre during Round-1 Counselling, candidate will have the facility to Swap / Add / Up / Down their Choices but he will not have the facility to Remove / Deleted their Round-1 allotted choice from the choice list.
 - (v) Whose Round-1 Counselling allotted seat cancelled due to discrepancy generation during document verification.
 - (vi) Who have not been allotted any seat in Round-1 Counselling.
- (g) On the basis of online choice filling of the candidate, provisional seat allotment order will be issued. Final seat allotment/admission will be subject to verification of their identity and original certificates at reporting centre fixed by the Board.

- (h) Before downloading of provisional seat allotment order, it is necessary for those candidate who want to upgrade their allotted seat, to give willingness for upgradation as “Yes” else “No”.

No.MCI-34(41)/2019-Med./112862.— In exercise of the powers conferred by Section 33 of the Indian Medical Council Act, 1956 (102 of 1956), the Board of Governors in super-session of Medical Council of India with the previous sanction of the Central Government, hereby makes the following Regulations to further amend the “Graduate Medical Education Regulation, 1997”, namely: —

1. (i) These Regulations may be called the “Graduate Medical Education Regulations, (Amendment), 2019”.

(ii) They shall come into force from the date of their publication in the Official Gazette.

2. In the “Regulations on Graduate Medical Education, 1997”, in Appendix “H” - Guidelines regarding admission of students with “Specified Disabilities” under the Rights of persons with Disabilities Act, 2016 with respect to admission in MBBS —shall be substituted with Appendix “H-1”.

Appendix “H - 1”

Guidelines regarding admission of students with “Specified Disabilities” under the Rights of Persons with Disabilities Act, 2016 with respect to admission in MBBS Course.

- Note : 1. The “Certificate of Disability” shall be issued in accordance with the Rights of Persons with Disabilities Rules, 2017 notified in the Gazette of India by the Ministry of Social Justice and Empowerment [Department of Empowerment of Persons with Disabilities (*Divyangjan*)] on 15th June 2017.
2. The extent of “specified disability” in a person shall be assessed in accordance with the “Guidelines for the purpose of assessing the extent of specified disability in a person included under the Rights of Persons with Disabilities Act, 2016 (49 of 2016)” notified in the Gazette of India by the Ministry of Social Justice and Empowerment [Department of Empowerment of Persons with Disabilities (*Divyangjan*)] on 4th January 2018.
3. The minimum degree of disability should be 40% (Benchmark Disability) in order to be eligible for availing reservation for persons with specified disability.
4. **The term ‘Persons with Disabilities’ (PwD) is to be used instead of the term ‘Physically Handicapped’ (PH).**
